Dear FOI Team

I refer to your FOI response dated 25 October 2019.

Thank you for the Freedom Of Information (FOI) results.

I note that the FOI search result failed to identify any information, documentary evidence or proof that workers were ever provided with the Workplace Privacy Policy 2011.

You have confirmed this in various parts of your findings, with the main confirmation being on page 1.

(Decision on access - page 1)

"No documents were identified,"

Audit of workers signing a document (page 3)

"I have not identified any record of workers signing a document that they have been provided with the Workplace Privacy Policy 2011."

Operational Guidance on the Workplace Privacy Policy 2011 (page 3)

"No documentation within the scope of your request has been identified for the period 2011 - 2016 covering the former Territory and Municipal services directorate (TAMS)"

"No operational guidance documents since 2016 or an explanatory reference to this policy have been identified"

I also note that there does not appears to be any documentary evidence or proof that workers were ever notified of the nature and purpose of **workplace** surveillance operating within workplaces.

I do not believe that the use of optical devices at Depots have been explained to workers.

I do not believe that covert surveillance has been explained to workers and Depot managers. I have reason to believe that Managers at a Depot were using covert surveillance to entrap workers. They may have even terminated their work.

I refer to the following legislative statement that does not appear to have been done especially in 2016 to 2017 when the majority of surveillance tracking devices were fitted to vehicles and mowers.

This is a requirement by law.

"The Act requires that ACT employers notify workers of the nature and purpose of workplace surveillance operating within workplaces. The Workplace Privacy Policy and Notice to Workers sets out the type and purpose of surveillance operating in ACT Government workplaces"

I would like to point out that you added a statement (Listed below) in your FOI results that is not constant with the findings. You have not provided any evidence to confirm that your statement is true or that the action has been done. It can only be seen as speculation based on conjecture as it contradicts the search results in the FOI request.

"As far as can be ascertained, all workers in ACT government were notified of the Workplace Privacy Act 2011 and the whole of government policy in 2011."

This statement needs some form of proof as it may mislead the public into believing that this action was done when they read the disclosure log. Statement such as this should not be made without proof as it contradicts the findings in this FOI request. "No documents were identified,".

When I made an enquiry about your statement, (listed above) you responded with the following statement in your letter dated 22nd November 2019.

"The Workplace Privacy Policy statement and notice were addressed to all staff and was circulated by the Head of Service, Chief Ministers and Cabinet Directorate in 2011".

Again you have not provided any documentary evidence or proof to confirm that your statement is true or that the action has been done. Again, it can only be seen as speculation based on conjecture as it contradicts the search results in the FOI request.

I am not sure if these two statements comply with the following section of the Freedom of Information Act 2016 as they may not be accurate and they may be misleading. There is no evidence or proof to confirm that they are true and that the action has been done.

"6 Objects of Act"

"(*g*) ensure that personal information held by the Territory is accurate, complete, up-to-date and not misleading".

I draw your attention to the fact that the Workplace Privacy Policy 2011 is addressed to the Directors General, HR Directors, Managers, Shared Services.

These recipients and stakeholders are within Transport Canberra and City Service (TCCS), (Territory and Municipal Services (TAMS) in 2011) so they must take responsibility and management of this policy and comply with law.

I also draw your attention to the **Territory Records Act 2002**.

"The Territory Records Act 2002 establishes that each agency is required to develop and maintain a Records Management Program that includes requirements for the creation, management, protection, preservation, storage and disposal of, and access to records of the agency"

The Director General, HR Director, Managers and Shared Services must comply with the Territory Records Act 2002 as the Workplace Privacy **Policy** 2011 was addressed to them which in turn falls under their control and management.

Workers within City Services must be notified of surveillance law before using vehicles and mowers that have been fitted with electronic surveillance tracking devices.

I request the following information under the Freedom of Information Act 2016 (FOI).

• I request documentary evidence as proof that workers were notified of the *Workplace Privacy Act 2011* to corroborate your claims listed below. (ie. file name, reference number, date sent to stakeholders, date workers were notified).

Your statement is based on conjecture in your FOI response Ref: 19-086 dated 25th October 2019

"As far as can be ascertained, all workers in ACT government were notified of the Workplace Privacy Act 2011 and the whole of government policy in 2011."

• I request documentary evidence as proof that the *Workplace Privacy Policy statement and notice was circulated* to corroborate your claims listed below. (ie. file name, reference number, date sent to stakeholders, date workers notified, circulated to whom)

Your statement is based on conjecture in your letter Ref: 19-086 dated 22th November 2019

"The Workplace Privacy Policy statement and notice were addressed to all staff and was circulated by the Head of Service, Chief Ministers and Cabinet Directorate in 2011."

• I also request information on "how" workers were notified of the Workplace Privacy Act 2011.

FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 9 April 2020, in which you sought access to:

- Documentary evidence as proof that workers were notified of the Workplace Privacy Act 2011;
- Documentary evidence as proof that the Workplace Privacy Policy statement and notice was circulated.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance of section 40 of the Act, CMTEDD was required to provide a decision on your access application by 12 May 2020.

Decision on access

Searches were completed for relevant documents and one document was identified that falls within the scope of your request.

I have included as **Attachment A** to this decision the schedule of relevant documents. This provides a description of the document that falls within the scope of your request and the access decision for that document.

I have decided to grant full access to the relevant document.

Charges

Processing charges are not applicable for this request because the number of pages to be released to you is less than the charging threshold of 50 pages.

Online publishing – Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents released to you in response to your access application will be published in the CMTEDD disclosure log after 24 April 2020. 
I've conducted e-discovery on our mail exchange based on the keyword "Workplace Privacy Act 2011" for the month August 2011 and

- the results shows (per attached screenshot) emails sent out from mailbox: "HRMS.PAYSLIP@act.gov.au" and received by using a distribution list as an example: # all staff CMTEDD,
- This means the HRMS.PAYSLIP email could've been used for WhoG staff communication on 2011 instead of current publication mailbox and assuming all staff receiving their payslips from this mailbox should have received the privacy act2011 attached.
- Searching mailbox: "HRMS.PAYSLIP@act.gov.au" to recover the items in sent folder for that date has failed which could be the result of moving mailboxes to exchange O365 and it's now beyond the legal hold of 7 years and not recoverable after retention period.

However, it is possible to search a staff member's actual mailbox and find the email to prove if the staff member

requesting the FOI has received the email in 2011 to go further with this, otherwise below screenshot's proves email has been sent out on 10/08/2011.
