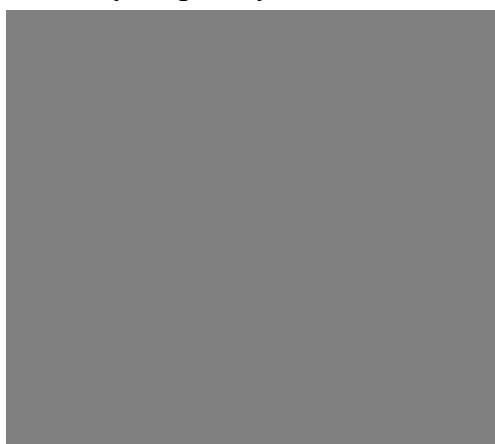

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance of section 40 of the Act, CMTEDD was required to provide a decision on your access application by 13 July 2020.

Decision on access

Searches were completed for relevant documents and four documents were identified that fall within the scope of your request.
