A growing body of evidence on the gendered nature of COVID-19 and the concomitant social distancing measures points to an increased unpaid workload for women and spiralling rates of domestic violence.</li> <li>The Community Recovery Roadmap will engage those most adversely impacted by COVID-19, including women, to ensure their voices and experiences are reflected in the Community Recovery Plan.</li> <li>In relation to the community resilience component, it aims to address the isolating and harmful impacts of COVID-19 and social distancing, which, given women in many ways are more vulnerable as a result, will have a beneficial impact on women.</li> </ul>

This facilitates a continuity of service provision and connection through COVID-19.</li> </ul>
