Authority

As an appointed Information Officer under section 18 of the Act, I am authorised to make a decision on access or amendment to government information in the possession or control of CMTEDD.

Timeframes

In accordance of section 40 of the Act, CMTEDD was required to provide a decision on your access application by 26 May 2021.

Decision on access

A search of CMTEDD records has failed to identify any documentation in relation to your request. The search was conducted using the information you provided.

As advised to you in your previous FOI request, CMTEDDFOI 2020-241, the identification survey from Select Structures was requested by Access Canberra, however Access Canberra did not direct that it be supplied by under s79 of the

Construction Occupations (Licensing) Act 2004. This is still an ongoing project and the Building Approval is still active.

I am satisfied that appropriate searches were completed and that no documents relevant to your request are held by CMTEDD.

Charges

Pursuant to Freedom of Information (Fees) Determination 2017 (No 2) processing charges are not applicable for this request because there are no documents available to be processed.
