

FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 7 May 2021.

Specifically, you are seeking: The classification and position numbers on Executive Contracts tabled in the ACT Legislative Assembly on:

- 2011 Weekly Hansard 18 October 2011 for - David A Roulston dated 5/9/2011;
- 2011 Weekly Hansard 15 November 2011 for - Colm Mooney dated 26/10/2011 and Glenn Lacey dated 21/10/2011.

On 2 June 2021, CMTEDD accepted a full transfer request from the Office of the Legislative Assembly (their reference: OLA21-0083). The transfer was for an identical request that you sent to them on 7 May 2021.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD was required to provide a decision on your access application by 7 June 2021.

Decision on access

Searches were completed for relevant documents and one document was identified that falls within the scope of your request.

I have decided to grant full access to the relevant document. The document released to you is provided as **Attachment A** to this letter.

Charges

Processing charges are not applicable for this request because the total number of pages to be released to you is below the charging threshold of 50 pages.
