FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 25 September 2021, in which you sought access to:

- Documents from within the ACT Housing Directorate relating to the development of a dual occupancy at 51 a and b Campbell Street in Ainslie and the ongoing negative impacts it has had on existing residents since its development.
- I specifically require documents relating to advice sent to neighbouring residents prior to the units being built which outlined their intended use. This information was part of the normal building approval process.
- I seek to know the number and nature of complaints ACT Housing has received from neighbouring residents about disruptions relating to multiple ACT Housing tenants in both these houses since they were built.
- I seek the number of times police have been called to attend these houses since they have been built.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 25 October 2021.

Decision on access

A search of CMTEDD records has failed to identify any documentation in relation to your request. The search was conducted using the information you provided. Your request has been partially transferred to Community Services Directorate (CSD) as Housing ACT sits within that Directorate. Environment, Planning and Sustainable Development Directorate

(EPSDD) have informed us that they already have this request from you and so we have not transferred any of your request to them.

If relation to point four of your request the ACT Government does not hold statistics of ACT Policing attendances. The ACT Policing Freedom of Information section can be reached by emailing FOI@afp.gov.au.

I am satisfied that appropriate searches were completed and that no documents relevant to your request are held by CMTEDD.

Charges

Pursuant to *Freedom of Information (Fees) Determination 2017 (No 2)* processing charges are not applicable for this request because no documents are being released to you.
