FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 27 October 2021, in which you sought access to:

"...investigation of 86 Candles Pty Limited, Pink Frosting and Louise Curtis, all email correspondence between 1 January 2018 to 27 October 2021 between the following parties - noting that some or all parties may be on email correspondence (ie. some emails may only be between two parties, some may be between all parties) - we require the entire suite of emails with any of the following senders or recipients on the email in relation to the above matters:- Rohan Connor David Snowden Derise Cubin Julia Burns Chantel Potter Alexandra Collins Tanja Warre Aiden Prescott Wendy-Maree Harrison David Pryce Stephen O'Rourke Shane Rattenbury (and/or Shane Rattenbury's office on his behalf).

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 24 November 2021.

On 5 November 2021 I wrote to you proposing to refuse to deal with your request as it would require an unreasonable and substantial diversion of resources pursuant to section 44(1) of the Act. In that letter you were provided with the opportunity to amend your application. The time allowed for your response to my proposal, as stated under section 46(4)(a) was 10 working days meaning a response was due to this office by 19 November 2021. I did not receive a response by that date.

Proposed Decision on Access

Based on the estimated time and resourcing it would take to process your request I am proposing to refuse to deal with this access application under section 43(1)(a) of the Act. Dealing with this request in its current form would require an unreasonable and

substantial diversion of resources pursuant to section 44(1) of the Act. I have considered the public interest that would be advanced by processing this request in its current form and have concluded that it does not justify the use of the required resources.

Decision on access

I have decided to refuse to deal with your application under section 43(1)(a) as an unreasonable and substantial diversion of resources.

Charges

Processing charges are not applicable for this request because no pages are being released to you.

Online publishing - Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. Your original access application and my decision in response to your access application will be published in the CMTEDD disclosure log 3 days after the date of my decision. Ombudsman Review
