FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 1 March 2022, in which you sought access to:

 A copy of the Standard & Poor Global Credit Rating Report on the ACT Government dated November 2021.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD was required to provide a decision on your access application by 30 March 2022.

Decision on access

I have decided to refuse to deal with your application under section 43(1)(d) as the information you have requested is publicly available from Standard & Poor [see: <u>S&P Global Ratings (spglobal.com)</u>] following your acceptance of their terms and conditions in receiving the report.

The ACT Government has committed to abide by the terms and conditions laid out by Standard & Poor and so to make a copy of the report available to a third party who would not be bound by the terms and conditions would be inappropriate and potentially, leave the ACT Government open to legal action.

Charges

Processing charges are not applicable for this request because no documents are being released to you.

Ombudsman Review
