I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 8 June 2022.

Authority

As an appointed Information Officer under section 18 of the Act, I am authorised to make a decision on access or amendment to government information in the possession or control of CMTEDD.

Timeframes

In accordance with section 40 of the Act, CMTEDD was required to provide a decision on your access application by 7 July 2022 however, following an extension and third-party consultations, the due date is now 18 August 2022.

Third Party Consultation

In making this decision, I completed consultation with relevant third parties in accordance with section 38 of the Act. The views of the third parties were taken into account in making this decision.

Decision on access

Searches were completed for relevant documents and 55 documents were identified that fall within the scope of your request.

I have decided to refuse access to all documents as I consider them to be:

contrary to the public interest information under schedule 1

My access decisions are detailed further in the following statement of reasons in accordance with section 54(2) of the Act.

Statement of Reasons

In reaching my access decisions, I have taken the following into account:

- the Act;
- the content of the documents that fall within the scope of your request; and
- the views of third parties consulted.

Exemption claimed

My reasons for deciding not to grant access to the identified documents are as follows:

Contrary to the public interest information under schedule 1 of the Act

All the identified documents are entirely composed of, or contain, information that is considered to be contrary to the public interest under schedule 1 of the Act.

- 1) Information the disclosure of which would, or could reasonably be expected to—
 - (a) prejudice the investigation of a contravention or possible contravention of the law in a particular case.
 - (e) prejudice a person's fair trial or the impartial adjudication of a matter before a court or tribunal.

It is publicly known that the Integrity Commission is investigating the circumstances surrounding the awarding of consultancy contracts by the Canberra Institute of Technology. The Integrity Commission was consulted as a third party under section 38 of the Act, as information in scope of your request was considered to be of concern to them. The Integrity Commission had submitted that these documents could reasonably be expected to prejudice an investigation or prejudice impartial adjudication of a matter, and I am in agreement with this consideration.

Charges

Processing charges are not applicable for this request because no pages are being released to you.

Online publishing - Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. Your original access application and my decision in response to your access application will be published on the CMTEDD disclosure log after 3 days after the date of my decision. Ombudsman Review
