FREEDOM OF INFORMATION REQUEST – NOTICE OF DECISION

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 27 February 2024.

Specifically, you have sought access to the following information:

“Transport Ministers Report in 2016 or 2017 explaining supported consultation process with taxi owners outlining justification of annual taxi lease fee rates dropping from \$20,000 per annum down to \$10,000 in 2018. Taxi leases crash to \$5,000 for ACT taxi owners in 2017.”

Authority

I am an Information Officer appointed by the CMTEDD Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application within 30 days. Therefore, a decision is due by **12 April 2024**.

Decision on access

I have decided to refuse to deal with your application in full under section 35(1)(c) of the Act. I have decided to refuse to deal with your application under section 43(1)(d) of the Act because the information you have requested is already available to you. The information is already available to you as under section 45(a) of the Act the information is publicly available.

Statement of Reasons

In accordance with section 55 of the Act a statement of reasons outlining my decisions is below. In reaching my access decisions, I have taken the following into account:

- the Act
- the information that falls within the scope of your request
- publicly available information.

As the decision maker, under section 55 of the Act, provide I am required to provide the following:

*“(a) the ground under section 43 (1) for the refusal;
(b) the findings on any material questions of fact referring to the evidence or other material on which the findings were based;
(c) if the ground is that the government information is already available to the applicant—how the applicant can access the information;
(d) that the applicant is not entitled to a refund of any application fee paid if the respondent refuses to deal with the application.”*

This notice sets out the evidence for my decision and details on how you can access the publicly available information.

Scope of your request and Searches

Searches for records have been undertaken using your scope of requested information, including searches for records in the context provided by you. This includes, but not limited to, searches relating to ‘report’ and ‘taxi’. We note that your date range included 2016 and 2017.

Searches of CMTEDD records have identified two documents within the scope of your request.

Enquiries were also undertaken with other ACT Government Directorates likely to hold records related to your request. Searches identified that relevant documents being identified as already available to you as the information is already publicly available.

Publicly available information

The records identified as relevant to your application are detailed below. 
ACT Civil and Administrative Tribunal (ACAT) Review
