### **Request under the Freedom of Information Act 1998**

I refer to your email dated 4 March 2013 where you sought access, under the *ACT Freedom of Information Act 1989* (FOI Act), to documents relating to:

*“work undertaken on Flemington Rd, Harrison during November 2012, specifically copies of relevant documents for the period 20 November 2012 to 4 March 2013.”*

I am the officer authorised under section 22 of the FOI Act to make a decision in relation to your request.

### **Decision**

I have located the following relevant documents, folios 1 – 112 and 114 – 150 from file 10/7366 Flemington Road Duplication – 2008.0356, and folios 151 to 281 extracted from a CD which relate to work undertaken on Flemington Rd, Harrison (20 November 2012 to 4 March 2013), which you refer to in your request:

- from file 10/7366 Flemington Road Duplication – 2008.0356 folios 1 – 15, 28 – 64, 77 – 112 and 114– 150 (less those folios being duplications or previously released under FOI) are fully released;
- from the CD folios 151 to 281 (less those folios being duplications or previously released under FOI) are fully released; and
- from file 10/7366 Flemington Road Duplication – 2008.0356 folios 16 – 27 and 65 – 76 are withheld subject to third party consultation.

The documents subject to third party consultation are not released in accordance with the following section of the FOI Act:

- section 27 – ‘ procedure on request in respect of document relating to business affairs etc’.

Please find enclosed the folio schedule and copies of the fully released documents. As advised by Ms Olwen Conran on 23 May 2013, a decision on the release of the documents pertaining to section 27 will be made within a 28 day period and you will be advised accordingly.

### **Right of Review**

You have the right to complain to the Ombudsman about the processing of your request pursuant to section 54 of the FOI Act. If you wish to lodge a complaint you should write to:


