FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 21 June 2019, in which you sought access to:

- 1. "The nominee or builders' details for the building licence of Tranquility Living Pty Ltd acn (612 531 272);
- 2. This includes Name, business address, postal address, and email address;
- 3. Personal details of ACT builders licence number 2018490 (believed to be Kevin Wilson);
- 4. Builders details of licence being used to construct a development at 15 Lumeah, Street Narrabundah ACT;
- 5. Also the same detail for the property at 55 Annabelle view, Coombs ACT".

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance of section 40 of the Act, CMTEDD was required to provide a decision on your access application by 19 July 2019.

Decision on access

Searches were completed within the construction licencing database for relevant information and this was transcribed into an email which then fell within the scope of your request.

I have included as **Attachment A** to this decision the schedule of relevant document. This provides a description of the document that falls within the scope of your request and the access decision for that document.

I have decided to grant partial access to 1 document relevant to your request as I consider it to contain some information that on balance, is contrary to the public interest to disclose under the test set out in section 17 of the Act.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as **Attachment B** to this letter.

In accordance with section 54(2) of the Act a statement of reasons outlining my decisions is below.

Statement of Reasons

In reaching my access decisions, I have taken the following into account:

- the Act;
- the content of the documents that fall within the scope of your request;
- the Human Rights Act 2004.

Public Interest Test under schedule 2 of the Act

The Act has a presumption in favour of disclosure. As a decision maker I am required to decide where, on balance, public interests lies. As part of this process I must consider factors favouring disclosure and non-disclosure.

In Hogan v Hinch (2011) 243 CLR 506, [31] French CJ stated that when 'used in a statute, the term [public interest] derives its content from "the subject matter and the scope and purpose" of the enactment in which it appears'. Section 17(1) of the Act sets out the test, to be applied to determine whether disclosure of information would be contrary to the public interest. These factors are found in subsection 17(2) and Schedule 2 of the Act.

Taking into consideration the information contained in the documents found to be within the scope of your request, I have identified that the following public interest factors are relevant to determine if release of the information contained within these documents is within the 'public interest'.

Factors favouring disclosure (Schedule 2.1)

2.1(a)(xiii) contribute to the administration of justice generally, including procedural fairness

<u>Factors favouring non-disclosure (Schedule 2.2)</u>

2.2(a)(ii) prejudice the protection of an individual's right to privacy or any other right under the Human Rights Act 2004

Having considered the factors identified as relevant in this matter, I consider that the release of the information you have requested may contribute to procedural fairness by allowing you to have a complete record of the data associated with building licence number 2018490.

However, when considering this finding against the factors favouring non-disclosure, I am satisfied that the protection of an individual's right to privacy, especially in the application process for a legislated licence is a significant factor as the parties involved have provided

their personal information for the purposes of direct communication between the applicant and the regulatory business unit which, in my opinion, outweighs the benefit which may be derived from releasing the personal information of the individual's involved in this matter. These individuals are entitled to expect that the personal information they have supplied as part of this process will be dealt with in a manner that protects their privacy.

Having applied the test outlined in section 17 of the Act and deciding that release of email addresses contained in the documents are not in the public interest to release, I have chosen to exclude this specific information (email addresses) in accordance with section 50(2). Noting the pro-disclosure intent of the Act, I am satisfied that excluding only the information that I believe is not in the public interest to release will ensure the intent of the Act is met and will provide you with access to the majority of the information held by CMTEDD within the scope of your request.

Charges

Pursuant to *Freedom of Information (Fees) Determination 2018* processing charges are not applicable for this request because the total number of pages to be released to you does not exceed the charging threshold of 50 pages.

Online publishing - Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents released to you in response to your access application will be published in the CMTEDD disclosure log after 18 July 2019. Ombudsman Review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act.
