## 20/359 CSD 2020-21 Supply Bill Omnibus

## **Summary of impacts:**

- The CSD Omnibus highlights the breadth and depth of work underway across government and the community to reduce the impacts of domestic and family violence in the ACT and support gender equality by offsetting the impact of COVID-19 on women's employment opportunities and participation.
- The ACT Government acknowledges that women and their children make up the largest cohort of domestic and family violence victims, and work to address domestic and family violence must focus on those who use violence and support those experiencing violence.
- Additionally, Young women in particular will benefit from a women in trades program to facilitate connections between industry organisations and schools in the ACT.
- There are no anticipated environmental impacts.

	Gender Equality	While the ACT Government acknowledges that women and their children make up the largest cohort of DFV victims, government work to address DFV is inclusive of different groups (both as those who use violence and those experiencing violence) to reflect that men and same sex couples also experience DFV.

Positive	Health (Community and mental health)	<ul> <li>Drawing on Australian and international studies, the Australian Institute of Health and Welfare found an association between women experiencing DFV and a wide range of health impacts.</li> <li>They found that among women 18 to 44 years, DFV was the biggest single risk factor when violence in all intimate relationships was included, bigger than smoking, alcohol use or being overweight or obese.</li> <li>When considering only violence by live-in partners, in</li> </ul>
		this age group, partner violence ranked second only to alcohol use.
Positive	Access to services	The CSD Omnibus initiatives work to remove barrier to people seeking help, provide new or improved service, or make it easier for people to access services.
Positive	Housing and Affordable housing	<ul> <li>Escaping DFV contributes to housing stress and crisis.</li> <li>The CSD Omnibus initiatives aim to better support service providers and reduce the scale of DFV to help ease the pressure on housing stocks.</li> </ul>
Positive	Homelessness support	<ul> <li>DFV remains the primary cause of women's homelessness in Australia.</li> <li>Safe and accessible housing is essential to the wellbeing of women and their children.</li> <li>In 2015, Housing ACT updated its Domestic and Family Violence Manual to better reflect contemporary approaches in responding to domestic and family violence, and to ensure support and assistance is timely and appropriate to the needs of the person who has been affected by the violence.</li> </ul>
Positive	Access to social inclusion/participation and community activities	<ul> <li>People who experience DFV are often isolated by the person using violence.</li> <li>The CSD Omnibus aims to reduce barriers to help-seeking for people who are isolated by delivering more services in new ways. This includes delivering services where people can access them.</li> </ul>
Positive	Human rights	<ul> <li>By its very nature, DFV violates the fundamental human rights outlined in the ACT Human Rights Act 2004.</li> <li>The CSD Omnibus initiatives offer a suite of business cases aiming to support those experiencing violence and those using violence.</li> </ul>
Positive	Aboriginal and Torres Strait Islander	The ACT Government acknowledges the impact of family violence on Aboriginal and Torres Strait Islander people, their families and communities. The ACT Government is committed to a whole of community approach and working with Aboriginal and Torres Strait Islander people to address family violence.
