#### FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 16 September 2021, in which you sought access to:

 The community consultation process regarding the developments at the arboretum.

On 20 September 2021 you clarified the scope to:

· Consultation regarding the sealing River Road.

# **Authority**

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

## **Timeframes**

In accordance with section 40 of the Act, CMTEDD was required to provide a decision on your access application by 15 October 2021.

# Decision on access

A search of CMTEDD records has failed to identify any documentation in relation to your request. The search was conducted using the information you provided. I note that River Road is an internal service road and not a gazetted public road. The sealing of this road has links to operational requirements along with broadening public access to a greater proportion of the arboretum.
