



### FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 1 March 2022.

Specifically, you are seeking: *"Improvement notices issued to the Australian College of Nursing by WorkSafe ACT."* 

### Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

### Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 22 April 2022.

### **Decision on access**

I have decided to grant access in full to the relevant information which is included as **Attachment A** to this decision.

### Charges

Processing charges are not applicable for this request because the number of pages being released to you is below the charging threshold of 50.

#### Description

#### The inspector believes the person:

a) is contravening a provision of this Act; or

b) has contravened a provision in circumstances that make it likely that the contravention will continue to be repeated; and The provision that the inspector believes is being or has been contravened is **WHS Acts** Section number - **19** 

Briefly, how the provision is being, or has been, contravened:

I, Inspector Joanne Jeacocke conducted an inspection (refer to WPV 00098800) on the 19 November 2021 and received additional information/documents from the Australian College of Nursing on the 11 November 2021 and the 7 December 2021. On reviewing the inspection and the provided information/documents, at approximately 2:00pm on 4 February 2022, I Inspector Jeacocke formed a reasonable belief that the Australian College of Nursing has contravened a provision of the Work Health and Safety Act 2011 (the WHS Act) Sec 19 (3)(c).

Workers are at risk of psychological harm attributable to the Australian College of Nursing's failure to provide an adequate safe system of work for addressing bullying and harassment in circumstances when there is a real or potential conflict of interest where a person assigned with responsibilities/delegations in its Grievance and Dispute Management Procedure is party to the grievance. The Work Health and Safety (Preventing and Responding to Bullying) Code of Practice 2012 (CoP) made under the WHS Act 2011 specifies that any agreed workplace procedure should be neutral/impartial (this includes the way that people are treated in any process; the person in charge of an investigation or resolution process should never be directly involved in the incident they are investigating or attempting to address and they should also avoid any personal or professional bias).

This Notice may include directions concerning the measures to be taken to remedy the contravention or prevent the likely contravention, or matters or activities causing the contravention or likely contravention to which this notices relates. The inspector directs you to:

The Australian College of Nursing must so far as is reasonably practicable:

1. Undertake a review of the safe system for addressing bullying and harassment to ensure there are controls/measures built into the system to maintain neutrality as outlined in the CoP (4.3 Principles)

2. Consult with workers and/or their representatives who are, or are likely to be, directly affected by the safe system for addressing bullying and harassment

3. Provide any necessary information, instruction, training and supervision to workers who are, or a likely to be affected by the revised system

4. Develop a system to regularly review the controls/measures to ensure they remain fit for purpose, are being implemented, set up

and followed correctly.

5. Contact joanne.jeacocke@worksafe.act.gov.au and provide evidence of completion of points 1-4 above.

#### **Display of Notices**

A person to whom a notice is issued must, as soon as possible, display a copy of the notice in a prominent place at or near the workplace, or part of the workplace, at which work is being carried out that is affected by the notice (s 210(1)). A person must not intentionally remove, destroy, damage or deface a notice displayed under s 210(1) while the notice is in force (s 210(2)). The maximum penalty for failing to comply with these provisions is \$5,000 for an individual or \$25,000 for a corporation.

#### Compliance with direction or notice

The person to whom an improvement notice is issued must comply with the notice within the period specified in the notice.

Maximum penalty:

(a) in the case of an individual-\$50 000; or

(b) in the case of a body corporate-\$250 000

#### **Contents of Notice**

This Notice may state one or more of the following: (a) a workplace, or part of a workplace, at which the activity is not to be carried out; (b) anything that is not to be used in connection with the activity; (c) any procedure that is not to be followed in connection with the activity (s196(3)).

#### **Directions and recommendations**

A direction may refer to a code of practice and may offer the person a choice of ways in which to remedy the contravention (s 204). A Improvement notice may include recommendations. It is not an offence to fail to comply with recommendations in a notice (s205).

#### Changes to notice by inspector

An inspector may make minor changes to a notice for clarification, to correct errors or references, or to reflect changes of address or other circumstances (s206).

#### Privacy statement

WorkSafe ACT may obtain personal information about you in connection with this notice. The information may be collected and stored using the powers, and to carry out functions or activities, under the *Work Health and Safety Act 2011* and related work safety laws. Under that Act, the information can be disclosed to other ACT Government agencies or non-government organisations, and other Australian work safety enforcement agencies. WorkSafe ACT is obliged to handle your information openly, transparently and in accordance with the Territory Privacy Principles set out in the *Information Privacy Act 2014*. #### Review of this Work Health and Safety Act notice

Please ensure you include the notice number in your application for a review, together with the applicant's name and address, and the reason you are seeking the review.
