FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 25 May 2022, by way of transfer from Transport Canberra and City Services (TCCS) in which you sought access to:

- *“We wish to confirm if a Security license has been issued to the following entities: Security Master License for: [REDACTED]. And Security Employee License for: [REDACTED]. We would like to know if the licenses have been issued, date of issue, date of expiry and class type granted.”*

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 24 June 2022.

Decision on access

I have decided to refuse to deal with your application under sections 43(1)(d) and 45(c) of the Act.

Section 43(1)(d) states a respondent may refuse to deal with an access application wholly or in part only if— the government information is already available to the applicant.

Section 45(c) states government information is already available to the applicant only if the information— is available as part of a public register established under a territory law.
