FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on **15 February 2023**, in which you sought access to tender information regarding re-packaging RAT tests.

Specifically, you are seeking:

"The tender for re-packaging RAT tests went out to in Jan-Feb [20]22. The offer document, negotiations, financial records and contract of this process."

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance of section 40 of the Act, CMTEDD was required to provide a decision on your access application by **16 March 2023**.

Decision on access

The search was conducted using the information you provided. A search of CMTEDD records has failed to identify any documentation in relation to your request. As a tender process did not proceed and instead existing ACT Government employees were diverted to complete the re-packaging RAT tests roles.

I am satisfied that appropriate searches were completed and that no documents relevant to your request are held by CMTEDD.

Charges

Pursuant to Freedom of Information (Fees) Determination 2017 (No 2) processing charges are not applicable for this request because no documents are being released.
