In the orders made by Senior Member Hyman of the ACT Civil and Administrative Appeals Tribunal (ACAT) in [2021] ACAT 22 Phillips v AUSTRALIAN CAPITAL TERRITORY (AS REPRESENTED BY CHIEF MINISTER, TREASURY AND ECONOMIC DEVELOPMENT DIRECTORATE) (Discrimination), the member made the following order: "The ACT, in its role as insurer under the Safety, Rehabilitation and Compensation Act 1988 (Cth) and through its contracted claims manager and rehabilitation provider, must: (a) on the basis of the expert advice of a psychiatrist or clinical psychologist, provide training to those staff dealing with injured workers with a mental injury, so as to minimise the risk of triggering symptoms or otherwise exacerbating the injury; and (b) institute improved procedures for dealing with mental injuries aiming to: (i) avoid Information Act 2016 I delays in processing of claims; (ii) provide timely responses to enquiries by injured workers; (iii) keep injured workers informed of progress on their claims; and (iv) provide timely advice to injured workers regarding any impediments to claims being processed. Complete the introduction of the changes set out in (a) and (b) above by 31 March 2022." I am seeking the evidence of

training provided to those staff dealing with injured workers with a mental injury, so as to minimise the risk of triggering symptoms or otherwise exacerbating the injury, and to which position type this training has been provided (not individual names) Furthermore, I request: 1. The number of claims lodged to the ACT in it's capacity as an insurer under the Safety Rehabilitation and Compensation Act 1988 (Cth) on or after 31 March 2022 that contain a claim for psychological or mental health injury; and 2. The amount of time in days for each of these applications to reach a determination from the date of lodgement. I thank the Directorate for its attention to this matter. I am not seeking claim numbers or any personal data. I would be I do not want to access happy for those claims meeting the requirements to be simply the following referred to as claim 1, claim 2 etc, and to prevent any risk of documents in relation identifying any persons, the numbers not be in any specific order to my request:: of the claims lodged order.

#### FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 19 April 2023 in which you sough access to the following information.

On 8 May 2023, you amended the scope of your request to remove point 1, thus, this decision relates to the remaining two points of your request (as below):

- 1. The number of claims lodged to the ACT in it's capacity as an insurer under the Safety Rehabilitation and Compensation Act 1988 (Cth) on or after 31 March 2022 that contain a claim for psychological or mental health injury; and
- 2. The amount of time in days for each of these applications to reach a determination from the date of lodgment.

#### Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

#### Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 18 May 2023.

#### Decision on access

Searches were completed for relevant information maintained by CMTEDD, identifying answers to your request.

I have decided to grant full access to the available information. I have provided a schedule of the relevant information as Attachment A, and the corresponding material is released to you as Attachment B.

In accordance with section 54(2) of the Act a statement of reasons outlining my decisions is below.

#### Statement of Reasons

As a decision maker, I am required to determine whether the information within scope is in the public interest to release. To make this decision, I am required to:

- assess whether the information would be contrary to public interest to disclose as per Schedule 1 of the Act
- perform the public interest test as set out in section 17 of the Act by balancing the factors favouring disclosure and factors favouring non-disclosure in Schedule 2

#### The public interest information under schedule 2 of the Act

The Act has a presumption in favour of disclosure. As a decision maker I am required to decide where, on balance, public interest lies. As part of this process, I must consider factors favouring disclosure and non-disclosure.

Taking into consideration the information found to be within the scope of your request, I have identified that the following public interest factors are relevant to determine if release of the information contained within these documents is within the 'public interest'.

#### Factors favouring disclosure in the public interest:

- (a) disclosure of the information could reasonably be expected to do any of the following:
  - (i) promote open discussion of public affairs and enhance the government's accountability.
  - (ii) contribute to positive and informed debate on important issues or matters of public interest.

I have placed substantial weight on the above factors favouring disclosure. It is reasonable to expect that this information relates to a topic that many be of interest to the Canberra community. The release of this information can reasonably be expected to provide information that will inform the community, promote discussion and enhance debate, within the community.

I did not identify any factor favouring nondisclosure and have decided to release this information to you in full.

#### Charges

Processing charges are not applicable for this request because the number of pages released to you is below the charging threshold of 50.
