## FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 24 August 2023. Specifically, you requested information relating to:

*"I am seeking access to any correspondence Walter Sofronoff KC conducted with the media and journalists via any official BOI emails.* 

That is, what material did he send or receive to media outlets between February 2023 and August 2023."

## Authority

As an appointed Information Officer under section 18 of the Act, I am authorised to make a decision on access or amendment to government information in the possession or control of CMTEDD.

#### Timeframes

In accordance with section 40 of the Act, CMTEDD was required to provide a decision on your access application by 6 October 2023.

#### Decision on access

A thorough search of CMTEDD records has failed to identify any documentation in relation to your request. The search was conducted using the information you provided.

I am satisfied that appropriate searches were completed and that no documents relevant to your request are held by CMTEDD.

#### Charges

Pursuant to *Freedom of Information (Fees) Determination 2017 (No 2)* processing charges are not applicable for this request as no documents are being released to you.
