

FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 3 August 2023. Specifically, you sought the following:

- All correspondence and documentation regarding the resignation of Mr Damon Hall from the Government Procurement Board, including what information was exchanged with the Special Minister of State or his staff and correspondence to the Board surrounding his resignation.
- All correspondence relating to the Special Minister of State's decision to renew Mr Hall's membership to the board in 2021.
- All correspondence relating to Ms Susan Hall's resignation or dismissal from the Government Procurement Board since her appointment on 22 November 2019.
- Any and all conflicts of interest declared by Mr Damon Hall in his role as Member of the Government Procurement Board.
- Any and all conflicts of interest declared by Ms Susan Hall in his role as Member of the Government Procurement Board.
- All correspondence and documentation between the CEO of CIT and the Minister for Skills or his staff, surrounding a potential conflict of interest declared between the CEO of CIT's relationship to Think Garden CEO, Patrick Hollingworth and the subsequent contracts awarded to his company.

On 8 August 2023, the Canberra Institute of Technology (CIT) FOI team accepted transfer of the following two points of your request:

- All correspondence and documentation between the CEO of CIT and the Minister for Skills or his staff, surrounding a potential conflict of interest declared between the CEO of CIT's relationship to Think Garden CEO, Patrick Hollingworth and the subsequent contracts awarded to his company.
- All correspondence and documentation between the CEO of CIT, Leanne Cover, and the Minister for Skills or his staff, surrounding a potential conflict of interest between the CIT CEO and Patrick Hollingworth for all contracts first executed from 27 July 2017 until 28 March 2022 inclusive of contracted entities: Redrouge, Think Garden and Trustee for The Patrick Hollingworth Family Trust.

As such, please note that CIT will respond to you separately regarding these points.

Authority

I am an Information Officer appointed by the Director-General of CMTEDD under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD was required to provide a decision within 30 working days of receipt of your application. However, following third-party consultation, a decision on your access application is due by 6 October 2023.

Decision on access

An information search of CMTEDD records was conducted based on information provided by you. While some traditional documents were identified, information has also been provided in relation to several points of your scope in this response, following my statement of reasons. A statement of reasons is provided in accordance with section 54(2) of the Act.

I have included as **Attachment A** to this decision the schedule of relevant documents. This provides a description of each document that falls within the scope of your request and the access decision for each of those documents.

I have decided to grant access in full to three documents relevant to your request. I have decided to grant partial access to two documents and refuse to release one document, as I consider them to contain information that would, on balance, be contrary to the public interest to disclose under the test set out in section 17 of the Act.

My access decisions are detailed further in the following statement of reasons, in accordance with section 54(2) of the Act. The documents released to you are provided as **Attachment B** to this letter.

Why I intend to refuse your request

I intend to refuse to deal with a portion of your access application, under section 43(1)(a) of the FOI Act, because:

- dealing with the application would require an unreasonable and substantial diversion of resources pursuant to section 44(1)(a) of the FOI Act, and
- the resources required does not justify the public interest, refer section 44(1)(b) of the FOI Act.

The two points are:

- Any and all conflicts of interest declared by Mr Damon Hall in his role as Member of the Government Procurement Board.
- Any and all conflicts of interest declared by Ms Susan Hall in his role as Member of the Government Procurement Board.

Board members declare conflicts on each item presented to the Board and are recorded in the minutes of each meeting. The Board considers approximately 80 items per year. As Mr Hall's appointment term was close to five years, this request would be an unreasonable diversion of resources to gather the information from each minute. As Ms Hall's appointment term was three years, this request would be an unreasonable diversion of resources to gather the information from each minute.

Balancing the public interest that would be advanced by processing this request in its current form, I have concluded that it does not justify the resources required to complete it. This is contrary to the objects of the FOI Act, including under section 6(f): "facilitate and promote, promptly and at the lowest reasonable cost, the disclosure of the maximum amount of government information."

Statement of Reasons

In reaching my access decisions, I have taken the following into account:

- the Act
- the content of the documents that fall within the scope of your request
- the Human Rights Act 2004.

Exemption claimed

My reasons for deciding not to grant access to the identified documents and components of those documents are as follows:

Contrary to the public interest information under Schedule 1 of the Act

Some of the documents contain information that is considered to be contrary to the public interest under Schedule 1 sections 1.6 of the Act.

Under the Act schedule 1, section 1.6 Cabinet Information is:

(1) Information—

- (a) that has been submitted, or that a Minister proposes to submit, to Cabinet for its consideration and that was brought into existence for that purpose; or
- (b) that is an official record of Cabinet; or
- (c) that is a copy of, or part of, or contains an extract from, information mentioned in paragraph (a) or (b); or

(d) the disclosure of which would reveal any deliberation of Cabinet (other than through the official publication of a Cabinet decision).

The purpose of this exemption is to maintain the confidentiality of the Cabinet process and to uphold the principle of collective ministerial responsibility. This exemption was discussed in *The Commonwealth v Northern Land Council* [1993] HCA 24; (1993) 176 CLR 604 (21 April 1993). Paragraph 6 of the decision, states that:

... it has never been doubted that it is in the public interest that the deliberations of Cabinet should remain confidential in order that the members of Cabinet may exchange differing views and at the same time maintain the principle of collective responsibility for any decision which may be made.

Information that would divulge Cabinet deliberations has been redacted.

<u>Information that would, on balance, be contrary to the public interest to disclose under</u> the test set out in section 17 of the Act

What is the Public Interest?

The Act has a presumption in favour of disclosure. As a decision maker I am required to decide where, on balance, public interest lies. As part of this process, I must consider factors favouring disclosure and non-disclosure.

In Hogan v Hinch (2011) 243 CLR 506, [31] French CJ stated that when 'used in a statute, the term [public interest] derives its content from "the subject matter and the scope and purpose" of the enactment in which it [public interest] appears'. Section 17(1) of the Act sets out the test, to be applied to determine whether disclosure of information would be contrary to the public interest. These factors are found in subsection 17(2) and Schedule 2 of the Act.

Taking into consideration the information contained in the documents found to be within the scope of your request, I have identified that the following public interest factors are relevant to determine if release of the information contained within these documents is within the 'public interest'.

Factors favouring disclosure in the public interest under schedule 2.1:

- (a) disclosure of the information could reasonably be expected to do any of the following:
 - (i) Promote open discussion of public affairs and enhance the government's accountability;
 - (ii) Contribute to positive and informed debate on important issues or matters of public interest;
 - (iii) Inform the community of the government's operations, including the policies, guidelines and codes of conduct followed by the government in its dealings with members of the community.

I consider release of this information could reasonably be expected to promote discussion of public affairs, contribute to positive and informed debate and the government's accountability regarding the expenditure of public funds. The release of this information will provide insight in the process undertaken with regards to procurement.

I am satisfied that these factors favouring disclosure carry considerable weight. However, these factors are to be balanced against the factors favouring nondisclosure.

Factors favouring nondisclosure in the public interest:

- (a) disclosure of the information could reasonably be expected to do any of the following:
 - (ii) prejudice the protection of an individual's right to privacy or any other right under the Human Rights Act 2004.

Having reviewed the information, I consider that the protection of an individual's right to privacy, is a significant factor. Release of information concerning individuals working within the ACT Public Service is generally not considered to prejudice the protection of an individual's right to privacy. However, where mobile phone numbers may be used for home and work purposes, this information is redacted, as it could or would reasonably be expected to prejudice an individual's right to privacy under the *Human Rights Act 2004*. I have elected to redact Mr Hall's mobile number and his signature. I note that these redactions are minor in nature.

Several of the documents contain vast amounts of out-of-scope information. Where this is the only reason for redaction, in line with ACT Ombudsman Guidelines, this is taken as full release.

Having applied the test outlined in section 17 of the Act and deciding that release of some of the information contained in the documents is not in the public interest to release, I have chosen to redact this specific information in accordance with section 50(2). Noting the pro-disclosure intent of the Act, I am satisfied that redacting only the information that I believe is not in the public interest to release will ensure that the intent of the Act is met and will provide you with access to the majority of the information held by CMTEDD within the scope of your request.

Additional contextual information

 All correspondence relating to Ms Susan Hall's resignation or dismissal from the Government Procurement Board since her appointment on 22 November 2019.

Susan Hall did not resign nor was she dismissed; her appointment ceased at the end of its term.

 All correspondence and documentation between the Special Minister of State or his staff for potential conflicts of interest declared for the contract Contract - SA1534, especially as they relate to Karen Mann.

CMTEDD does not hold any information on this point.

Charges

I have waived fees associated with your access application because under section 107 of the Act, a Member of the Legislative Assembly is not to be charged a fee for an access application.

I am an Information Officer appointed by the Director-General of CMTEDD under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD was required to provide a decision within 30 working days of receipt of your application. However, following third-party consultation, a decision to partially release information was provided to you on 6 October 2023. However, you were also provided with a partial notice of intention to refuse as part of that decision notice for two items contained within the scope of your request.

Consultation

Under section 46(1)(a) of the Act, before refusing to deal with your application, CMTEDD was required to provide you, in writing, the grounds for the refusal, and (b) provide you with a reasonable opportunity to consult with CMTEDD and provide any additional information that is relevant. CMTEDD was also required to provide any information that may assist you in making an application in a form that would remove the grounds for refusal.

In accordance with section 46(1)(b), the consultation period as outlined in the Act is 10 days from the day after the notice was provided to you, meaning the consultation period has now expired. I note that my office has not had a response from your office.

I am satisfied that my office has made all reasonable attempts to assist you in making an application that would remove the grounds for refusal.

• dealing with the application would require an unreasonable and substantial diversion of resources pursuant to section 44(1)(a) of the Act, and
