

FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 12 December 2023. In your request you sought access to the following information:

1. All communication, including emails, transcripts of meetings, briefs, letters etc between the office of the Attorney General, including the Attorney General himself, and Ms Kathy Leigh, Head of Service, in relation to the advice provided to the Attorney General by Ms Leigh dated 6 February 2023 in relation to the matter at Access Canberra involving the Commissioner for Fair Trading.

2. All communication, including emails, transcripts of meetings, briefs, letters etc on the appointment of Ms Derise Cubin as Fair Trading Commissioner.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision within 30 working days of the access application being received. Therefore, a decision and response are due on 1 February 2024.

Decision on access

Searches were completed for relevant documents and several documents were identified that fall within the scope of your request.

Please note, under section 43(1)(6) of the Act, we can refuse to deal with requests for information already available to applicants. In line with section 45(e) of the Act, refusal of this information is because we previously provided you with documents regarding correspondence from the Minister, or his office between the ACT Attorney-General and the ACT Commissioner for Fair Trading. Please see CMTEDDFOI 2023-161 'Annual Reports Hearings and any conflicts of interest that were declared (2020-21-Present), and any

briefings, documentation and correspondence relating to the conflict of interest declared by the ACT Commissioner for Fair Trading on November 26, 2021'. This decision was published on the CMTDD disclosure log 5 July 2023. The link to the disclosure log is <u>Disclosure Log 2023 - Chief Minister, Treasury and Economic Development Directorate</u> (act.gov.au).

I have included as **Attachment A** to this decision the schedule of relevant documents. This provides a description of the documents that fall within the scope of your request and the access decision for those documents. I have decided to grant access in full to these documents.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as **Attachment B** to this letter.

In accordance with section 54(2) of the Act a statement of reasons outlining my decisions is below.

Statement of Reasons

In reaching my access decisions, I have taken the following into account:

- the Act
- the content of the documents that fall within the scope of your request
- the Human Rights Act 2004.

Exemption claimed

My reasons for deciding to grant access to the identified documents are as follows:

Public Interest

The Act has a presumption in favour of disclosure. As a decision maker I am required to decide where, on balance, public interest lies. As part of this process, I must consider factors favouring disclosure and non-disclosure.

In *Hogan v Hinch* (2011) 243 CLR 506, [31] French CJ stated that when 'used in a statute, the term [public interest] derives its content from "the subject matter and the scope and purpose" of the enactment in which it [public interest] appears'. Section 17(1) of the Act sets out the test, to be applied to determine whether disclosure of information would be contrary to the public interest. These factors are found in subsection 17(2) and Schedule 2 of the Act.

Taking into consideration the information contained in the documents found to be within the scope of your request, I have identified that the following public interest factors are relevant to determine if release of the information contained within these documents is within the 'public interest'.

Factors favouring disclosure in the public interest (Schedule 2 section 2.1):

(a) disclosure of the information could reasonably be expected to do any of the following:

- *(i)* promote open discussion of public affairs and enhance the government's accountability.
- (viii) reveal the reason for a government decision and any background or contextual information that informed the decision.

Having considered the factors identified as relevant in this matter, I consider that release of the information within the scope of the request may promote open discussion of public affairs and enhance the government's accountability. The release of the documents identified will provide contextual information relating to the appointment of the ACT Commissioner for Fair Trading.

I am satisfied there is public interest in the release of this information and have placed considerable weight on the above factors. I did not identify any factor favouring non-release and have decided to release this information to you in full.

Charges

I have waived fees associated with your access application because under



Dear Kathy and Ian

Could I please seek your advice on a matter that has been brought to my attention.

I seek your advice on: a) the appropriateness of the alleged conduct in Access Canberra; b) recommended action I should take as the Minister responsible for relevant areas of Access Canberra; and c) the appropriate way to respond to the legal and other questions I am receiving about this matter.

An allegation has been made by Ms Louise Curtis and her legal representatives that a conflict of interest was not dealt with appropriately in Access Canberra. The crux of this allegation is that the current Fair Trading Commissioner inappropriately attended a meeting without declaring that she is married to the former Fair Trading Commissioner, Mr David Snowden. The claim is made in the context of other legal action taken by Ms Curtis against the Commissioner. There is a history of interactions between Ms Curtis and Access Canberra, relating to Ms Curtis' former business, dating back several years. One of Ms Curtis' emails also alleges "doctoring of documents" and "perjury" (without further context).

My summary of action I have taken leading up to this request for further advice is as follows:

- My office received emails from Ms Curtis about the alleged conflict of interest. My office inquired with Access Canberra, and was alerted to the existing conflict of interest protocol that was in place. I received this advice and wrote to Ms Curtis noting this protocol.
- I received further correspondence from Ms Curtis specifying her concern that the protocol was not in place at the time a particular meeting took place (on 6 July 2021). My office sought further advice from Access

Canberra about these details. My office received further verbal advice, and subsequent written advice, from Access Canberra, clarifying that the relevant meeting on 6 July 2021 was a "without privilege" meeting, which occurred before legal proceedings had named Mr Snowden, and therefore the Fair trading Commissioner's attendance at the meeting was not inappropriate. The protocol was enacted after legal proceedings were formally commenced.

- On advice from Access Canberra, my office also replied to one of Ms Curtis' emails that her inquiries were best directed to Access Canberra, as they related to a current litigation matter.
- I am informed by Ms Curtis that the matter has also been referred to the ACT Integrity Committee.

I have been cognisant of the fact that the letters from Ms Curtis and her legal representatives relate to live legal proceedings involving the Government. You will also have seen this most recent issue was raised in Annual Reports and subsequently reported in the media.

I have not yet replied to further emails from Ms Curtis and her legal representatives while I seek further advice on the issues.

I have attached for your background: emails from Ms Curtis and letters from her legal representative relating to this specific allegation, information provided to me so far by Access Canberra, and replies that I and my office sent to Ms Curtis.

I would appreciate your advice on this matter. I would like to be satisfied that the actions of Access Canberra have been appropriate. I would also appreciate advice on how to respond to the legal inquiries I am receiving.


I am writing regarding a line of questioning relating to the Commissioner for Fair Trading during my attendance at the Annual Reports committee on 17 November 2023 in my capacity as Minister for Consumer Affairs. I wrote similarly to the Estimates Committee on 31 July 2023.

I note in particular that in Committee hearings this year, both Mr Cain and Ms Lee made various assertions about an alleged conflict of interest involving the Commissioner for Fair Trading. In doing so they asserted as 'facts' an interpretation of events that was inaccurate, including characterising a key meeting inaccurately. In making these assertions, Mr Cain and Ms Lee also personally named public servants. In this regard I ask that the Committee members review the transcripts, and standing order 264B, and consider whether further action is warranted.

As one of several examples, at the Committee hearing on 17 November, Mr Cain said:

"the fair trading commissioner did not declare she was married to the former trading commissioner *while presiding over a dispute involving that person*, who was her husband. That is the fact."

In the same session, Mr Cain described the situation as "a senior officer managing a dispute between a commercial entity and the former commissioner, who was her husband."



Mr Cain specifically names both parties during this session.

As another example, at the Committee hearing on 24 November, Mr Cain and Ms Lee say:

MR CAIN: Ms Leigh, if you were supervising Ms Cubin ... would you have been concerned that she was attending *to mediate a dispute involving her husband*? MS ORR: Chair, I seek your advice on whether this is hypothetical and therefore not allowed. MS LEE: This is actually not hypothetical.

I reiterate the following information to the Committee, summarising information provided by Access Canberra, to assist the Committee's understanding of this issue.

Attendance at the 6 July 2021 meeting

In June 2018, the former Commissioner for Fair Trading (Mr Snowden) initiated an investigation into a business as a result of consumer complaints in relation to that business. That investigation progressed but following confirmation that the business was to be deregistered, the former Commissioner determined that no further action would be taken and the investigation was subsequently closed in August 2020.

On 21 January 2021, the Territory was made aware of a potential claim for compensation in relation to the investigation.

On 27 May 2021, correspondence from the legal representative of the business sought to articulate a claim for compensation, but the proper basis of that claim was unclear. To progress the matter, the current Commissioner (Ms Cubin) attended a 'without prejudice' meeting on 6 July 2021 along with ACT Government Solicitor's representatives so that the legal issues in the matter and particulars of any potential claim against the Territory could be discussed. It was made clear prior to the meeting that the Territory was not able to make settlement offers at this stage but did consider that a discussion between the parties should enable the progression of the matter. I emphasise that *at this time the basis of the potential claim was not clear nor was it clear who would be the subject or respondent to any claim*.

Separate to the potential legal claim mentioned above, on 4 November 2021, proceedings were filed in the ACT Civil and Administrative Tribunal seeking a range of orders, including the release of certain information. I emphasise that it was these proceedings that named the Commissioner for Fair Trading and other individuals as respondents.

As a result of the ACAT proceedings naming the statutory office and individuals, Ms Cubin completed a conflict of interest disclosure declaration relating to that matter on 24 November 2021. On 30 November 2021 the Head of Access Canberra (Mr Pryce) implemented a Standard Operating Procedure (SOP) in response to this matter.

In providing the above information about the nature and timeline of the complaint and legal proceedings, I emphasise that Mr Cain and Ms Lee have been inaccurate in their characterisation of the situation.

I lastly emphasise, as noted numerous times before, that Access Canberra determined that it has taken appropriate actions in relation to this matter. In response to complaints from an external party, I sought independent confirmation from the Head of Service, who wrote to me on 6 February 2023 indicating that she had looked into the matter and advised that *"the Commissioner's attendance at the meeting on 6 July 2021 was appropriate. I am also satisfied that Access Canberra has appropriately managed any subsequent potential for conflict of interest in this matter."*

I request that the Committee take note of the matters I have raised.


