FREEDOM OF INFORMATION REQUEST – NOTICE OF DECISION

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 15 July 2024.

Specifically, you have sought access to the following information:

“Any footage if available of intersection of Launceston Street and Irving Street on 15/07/24 around 12:57pm to assist with whom is at fault of a collision.”

Authority

I am an Information Officer appointed by the CMTEDD Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application within 30 days. Therefore, a decision is due by **26 August 2024**.

Decision on access

A search of CMTEDD records has failed to identify any material within scope of your request. I am satisfied that appropriate searches were completed and that no footage relevant to your request is held by CMTEDD.

Our line area advised that there are no CCTV cameras owned or operated by ACT Government near the intersection of Launceston and Irving St Phillip.
