## FREEDOM OF INFORMATION REQUEST – NOTICE OF DECISION

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 9 June 2026.

Specifically, you have sought access to the following information:

“We are [REDACTED], in relation to a workplace accident involving [REDACTED] on 10 October 2023 (Incident). [REDACTED] was an employee of [REDACTED] at the time of Incident.

- ***We request a copy of WorkSafe ACT’s investigation report into the Incident pursuant to the ACT Freedom of Information Act 2016.***

### Authority

I am an Information Officer appointed by the CMTEDD Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

### Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application within 30 days.

Therefore, a decision is due by **21 July 2026**.

### Decision on access

Searches into CMTEDD/WorkSafe ACT records did not identify any information within the scope of your request.

WorkSafe ACT advised that there are no documents within the scope of your request but do hold other documents relating to the incident. I understand that the FOI Coordinator for this request phoned you on 24 June 2026 advising you of this. In that conversation you advised you were not interested in the additional documentation.

## Charges

Processing charges are not applicable for this request as no documents are being released to you.
