Freedom of information request – Kambah Skate Ramp/Bowl

I understand that Mr Adam Roach of the Territory and Municipal Services Directorate contacted you on 12 October 2012 to advise that the directorate was undertaking further searches in relation to your application made under the *Freedom of Information Act 1989* (the FOI Act) on 30 August 2012.

As a result of these searches, the directorate has located an additional four documents in relation to your request, as outlined in the schedule of documents at Attachment A. Further to my decision under the Act of 20 September 2012, I have decided to release or partially release all four of these documents to you.

I have decided to release document 1 to you in full.

I have partially exempted documents 2-4 from release pursuant to section 41(1) of the FOI Act, which provides:

41 Documents affecting personal privacy

- (1) A document is an exempt document if its disclosure under this Act would involve the unreasonable disclosure of personal information about any person (including a deceased person).

The exempt material contains personal information of third parties, who contacted the directorate about various matters relating to the Kambah skate bowl, including their surname and telephone details.
