Freedom of Information Request – Documents related to DA201017034

I refer to your application under section 14 of the *Freedom of Information Act 1989* (the Act), received by the Environment and Sustainable Development Directorate (ESDD) on 10 April 2014, in which you requested the following documents:

"Please provide copies of all documents and records relevant to DA 201017034 for Block 4 Section 46 Turner between ACTPLA and all other parties within and external to ACTPLA including "developer parties" from 8 March 2013 to 10 April 2014 inclusive. Please include all faxes, emails and records of phone conversations.

I am particularly interested in any changes to the ACAT approved plans and any problems with the survey commissioned for the DA application."

I am an officer authorised to make a decision in respect of a request for information, under section 22 of the Act.

Schedule detailing decisions

Please refer to the attached schedule that lists decisions regarding access to all documents, which have been identified as relevant to your request. The terms used on the schedule are 'Partial release' or 'Exempt'. Where an exemption is made, a reference will be made on the schedule to the relevant section or combinations of sections of legislation that apply to the decision.

Decision

The Directorate has identified 12 documents in its possession that meet the scope of your request, as identified in the schedule attached to this letter.

Under the Act, documents may be partially exempt/exempt or provided to applicants with deletions and I have decided to exempt some documents under section 41 (Documents relating to personal privacy).

Access to documents not to apply to certain documents

Personal Privacy

Section 41 of the Act provides:

- 1. a document is an exempt document if its disclosure under this Act would involve the unreasonable disclosure of personal information about any person (including a deceased person).*

Documents included in this response contain personal information about community members, which is exempt under the personal privacy provision of the Act.

Review rights

My decision is appealable under the Act. This means that if you are dissatisfied with this outcome you have a right to seek a review under section 59 of the Act. This right of review extends to a review of the adequacy of the search for documents undertaken by ESDD. If you wish to seek a review you should write to:

You have 28 days from the date of this letter to seek a review of the outcome or such other period as the Director-General permits.
