## Freedom of Information Request – ANU Community Outreach Program

I refer to your email dated 18 January 2016 to the Chief Minister, Treasury and Economic Development Directorate (CMTEDD), in which you seek access, under section 14 of the ACT *Freedom of Information Act 1989*, to a copy of the Deed of Grant between the ANU and artsACT, and the full audited financial statements from the ANU for the 2014 and 2015 financial years as to its full acquittal of these funds.

### Decision Maker

I am authorised under section 22 of the Act and have been appointed to make decisions on access to documents and liability for charges.

### Charges

I have decided under section 29 of the Act not to impose processing charges for this request.

### Identification of documents

Officers of CMTEDD have conducted searches of paper and electronic files and email accounts. Documents that are relevant to your request have been located in artsACT.

### Decision on Access

I have identified **three documents** that fall within the scope of your request, as detailed in the Schedule of Documents provided. I have considered these three documents and have decided to release all three to you in full.

### Your right of review

#### Internal Review

Under section 59 (1) of the Act, you may request a review of my decision. You have 28 days after receiving notice of my decision to ask for a review, or a further period as allowed by the Director-General.

I have assessed your request for information under the ACT Government's Online Freedom of Information Publication Policy and have determined that the documents relevant to your request, not including your original application, will be published online.

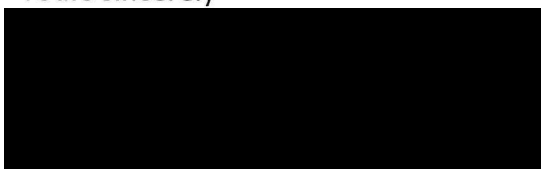
