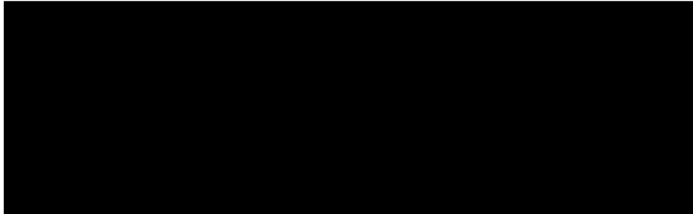

## **Decision on Freedom of Information Request – Kingston & Barton Residents Group**

I am writing in relation to your request for access to all correspondence received by the Chief Minister from the Kingston & Barton Residents Group Inc. (KBRG) since 1 January 2012, made under section 14 of the ACT *Freedom of Information Act 1989* (the Act). Your request was received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 16 September 2016.

### **Decision Maker**

I am authorised under section 22 of the Act to make decisions on access to documents and liability for charges.

### **Charges**

I have decided, under section 29 of the Act, not to impose processing charges for this request.

### **Identification of Documents**

Officers of CMTEDD have searched electronic and paper records for documents in the possession of the Directorate that may relate to your request. The documents identified as relevant to your request are detailed in the attached schedule.

### **Consultation**

In my letter of 11 October 2016 I explained that I would provide my decision on access to documents after consultation with relevant third parties who may wish to contend that documents should be exempt from release. I have now received and considered submissions from these third parties.

## **Decision on Access**

I have decided to partially release to you the identified documents, provided with this letter and described on the attached schedule. My reasons for not providing access to components of these documents are detailed in the following statement of reasons and in the attached schedule.

## **Exemptions claimed**

### Section 41 - Documents Affecting Personal Privacy

#### **Refers to folios:**

Section 41 of the Act provides:

- (1) *A document is an exempt document if its disclosure under this Act would involve the unreasonable disclosure of personal information about any person (including a deceased person).*

I have decided to exempt from release, under section 41 (1) of the Act, components of documents that contain names, signatures, contact details and other personal information about individuals who are not ACT Government employees. I consider that release of the information in these documents is likely to identify these individuals and would be an unreasonable disclosure of personal information and a breach of privacy.

In making my decision to exempt this information, I have considered that removal of this personal information does not materially affect the remaining content.

## **Your Right of Review**

### Internal Review

Under section 59 (1) of the Act, you may request a review of my decision. You have 28 days after receiving notice of my decision to ask for a review, or a further period as allowed by the Director-General.
