20-475 NDIS Update and Government Submission to Joint Standing Committee on NDIS Quality and Safeguards Commission

Summary of impacts:

The Joint Standing Committee into the Implementation, performance and governance of the National Disability Insurance Scheme (NDIS) will inquire and report on the operation of the NDIS Quality and Safeguards Commission (the Commission) since it commenced operation on 1 July 2019. At that time a number of functions that the ACT Government had retained were transferred to the Commission; including regulatory oversight, complaints investigations and incident management.

The submission formalises some of the ACT's concerns around unilateral decision making on the functioning's of the scheme and seeks to mirror sentiments from other States or Territories. It also includes broad feedback from several ACT stakeholders reflecting individual experiences with the Commission. The impact sought is an improvement in communication with the Commission for participants and those who make referrals and the resources for the Commission to respond in a timely and transparent way.
