FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 22 January 2021, in which you sought access to:

 Correspondence between the Chief Minister's office and the Australian National University regarding the return of students for 2021.

On 25 January 2021 you refined the request to exclude correspondence regarding the pilot program for international students

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD was required to provide a decision on your access application by 22 February 2021 however, following on from third party consultations, the due date is now 16 March 2021.

Decision on access

Following a search of CMTEDD records and third party consultation I have concluded that there are no documents that fall within the scope of your request. I am satisfied that appropriate searches were completed and that no documents relevant to the scope of your request are held by CMTEDD.

Charges
