## FREEDOM OF INFORMATION REQUEST

I am writing to you in response to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 29 November 2021, in which you sought access to:

"...any communication provided by the EDP to the National Capital Authority that might have informed the temporary traffic management plan that has been authorised for construction at 71 Constitution Avenue. Specifically, I need any communication regarding public safety aspects that would impact the street at Getting Crescent which is now totally unsafe for pedestrians and cyclists. Although the NCA had authority and granted the TTMP, they were required to consult the EDP and I need any records of this consultation. So far, my contact with EDP has been with Zebedee Mahoney | Team Leader – DA Lodgement who simply forwarded my request for information to the NCA.

#### Authority

As an appointed Information Officer under section 18 of the Act, I am authorised to make a decision on access or amendment to government information in the possession or control of CMTEDD.

#### **Timeframes**

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 29 December 2021.

#### **Decision on access**

A search was conducted with Zebedee Mahoney using the information you provided in your request and two documents were found. Mr Mahoney advised that you were copied into both these documents (emails). I have provided these as a courtesy as Attachment A.

Transport Canberra and City Services (TCCS) and Environment, Planning and Sustainable Development Directorate (EPSDD) were also contacted as asked if they hold any

information. Both Directorates advised they hold no documents in the scope of your request.

I am satisfied that no additional documents other than what is provided to you as <u>Attachment A</u> are held by CMTEDD.

## Charges


