FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 11 October 2023, in which you sought access to:

From the ACT Revenue Office website concerning those who download the Residential Tenancy Agreement (RTA). i) the number of RTA downloaded overall since it was available as a download ii) the number of RTA downloaded per year From the ACT Revenue Office website concerning those who submit a rental bond: iii) the total number of bonds submitted to date iv) the total number of bonds submitted on an annual basis since the rental bond submission process began.

Authority

As an appointed Information Officer under section 18 of the Act, I am authorised to make a decision on access to government information in the possession or control of CMTEDD.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 22 November 2023.

Decision on access

Searches were completed for relevant information within the scope of the access application. While the ACT Revenue Office (ACTRO) does not hold information about the number of RTA downloads in respect of items (i) and (ii) of the request, it has been possible to generate statistical data in relation to (iii) and (iv).

I have decided to grant full access to the statistical data, tabled as follows:

Pursuant to section 54(2) of the Act, a statement of reasons outlining my decision follows.

Statement of Reasons

As a decision maker, I am required to determine whether the information within scope is in the public interest to release. To make this decision, I am required to:

- assess whether the information would be contrary to public interest to disclose as per Schedule 1 of the Act, and
- perform the public interest test as set out in section 17 of the Act by balancing the factors favouring disclosure and factors favouring nondisclosure in Schedule 2.

I did not identify any Schedule 1 provisions as relevant to this request.

Public Interest under schedule 2 of the Act

The Act has a presumption in favour of disclosure. As a decision maker I am required to decide where, on balance, public interests lies. As part of this process, I must consider factors favouring disclosure and non-disclosure.

Taking into consideration the information found to be within the scope of your request, I have identified that the following public interest factors are relevant to determine if release of the information contained within these documents is within the 'public interest'.

Factors favouring disclosure in the public interest:

- (a) disclosure of the information could reasonably be expected to do any of the following:
 - (ii) contribute to positive and informed debate on important issues or matters of public interest;

I have placed weight on the above factor favouring disclosure. It is reasonable to expect that information about this topic may be of interest to the Canberra community and contribute to informed debate about issues of interest.

I did not identify any factor favouring nondisclosure and have decided to release this information to you in full.

Charges

Processing charges are not applicable for this request because the number of pages released to you is below the charging threshold of 50 pages.
