## **FREEDOM OF INFORMATION REQUEST – NOTICE OF DECISION**

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 29 July 2024.

Specifically, you have sought access to the following information:

*“Under the FOI Act I would like to be supplied with copies of the subject line of all final ministerial briefs for CMTEDD between the 1 Jan 2024 and 29 July 2024 generated for or directed to any ACT Government Minister.*

*This request includes, wherever possible, the date of the brief, the internal reference, position of authority it was written by, and which Minister it was addressed to.*

*This request includes briefs prepared for Question Time, Annual Reports and Estimates.”*

On 8 August 2024, you agreed to reduce the timeline of the scope to be from 29 March 2024 up to 29 July 2024.

### **Authority**

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

### **Timeframes**

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application within 30 days. However, on 22 August 2024 you agreed to a 15-working day extension, which was applied in accordance with section 41 of the Act. This resulted in a revised due date of 30 September 2024.

### **Decision on access**

Searches were completed for relevant information and **741** subject lines were identified that fall within the scope of your request. This information has been collated into a single document.

The document with the subject titles is listed in the schedule enclosed at **Attachment A**. This provides a description of the information that falls within the scope of your request and the access decision for this information.

## **Release of documents**

The information being released to you is provided at **Attachment B**.

Information that is out of scope has been removed. This information is not considered withheld under a provision of the Act as it does not fall within your scope.

## **Statement of Reasons**

In accordance with section 54(2) of the Act a statement of reasons outlining my decisions is below. In reaching my access decisions, I have taken the following into account:

- the Act
- the information that falls within the scope of your request
- *Human Rights Act 2004*
- *Tax Administration Act 1999*

As a decision maker, I am required to determine whether the information within scope is in the public interest to release. To make this decision, I am required to:

- assess whether the information would be contrary to public interest to disclose as per **Schedule 1** of the Act.
- perform the public interest test as set out in section 17 of the Act by balancing the factors favouring disclosure and factors favouring non-disclosure in **Schedule 2** of the Act.

## **Exemption claimed**

### **Schedule 1: Information taken to be contrary to the public interest.**

My reasons for deciding not to grant access to the identified documents and components of these documents are as follows:

#### **Contrary to the public interest information under schedule 1 of the Act**

A proportion of the subject lines identified contain information that is contrary to the public interest under Schedule 1 of the Act. Information that falls under the exemptions in Schedule 1 is not subject to the public interest test as detailed in section 17 of the Act.

### **Section 1.6 Cabinet information**

Various subject lines have been identified as information the disclosure of which would reveal deliberations of Cabinet.

Under section 1.6(1)(a) of the Act, information *that has been submitted, or that a Minister proposes to submit, to Cabinet for its consideration and that was brought into existence for that purpose* and section 1.6(1)(d) information *the disclosure of which would reveal any deliberation of Cabinet (other than through the official publication of a Cabinet*

*decision*) of Schedule 1 of the Act, is considered Cabinet information and is exempt from release. The purpose of this exemption is to maintain the confidentiality of the Cabinet process and to uphold the principle of collective ministerial responsibility.

This exemption was discussed in *The Commonwealth v Northern Land Council* [1993] HCA 24; (1993) 176 CLR 604 (21 April 1993). Paragraph 6 of the decision, states that:

*... it has never been doubted that it is in the public interest that the deliberations of Cabinet should remain confidential in order that the members of Cabinet may exchange differing views and at the same time maintain the principle of collective responsibility for any decision which may be made.*

Some of the information that you have requested falls within Schedule 1, section 1.6 of the Act as it is information which has been brought into existence to guide Cabinet in its decision making and assist it in its deliberations. It is reasonable to consider that the disclosure of this material would or could reveal those deliberations. Therefore, these various titles are exempt from release under the Act.

### **Section 1.3 Information disclosure of which is prohibited by law**

Division 9.4 of the *Tax Administration Act 1999* (TAA) contains a 'secrecy provision' as defined in Schedule 1, sections 1.3(6) and (7) of the Act.

Any information that falls within the meaning of 'information obtained under or in relation to the administration of a tax law ("tax information") in section 95(2) of the TAA is prohibited by law from disclosure.

### **Public Interest Test**

The Act has a presumption in favour of disclosure. As a decision maker I am required to decide where, on balance, public interest lies. As part of this process, I must consider factors favouring disclosure and nondisclosure.

In *Hogan v Hinch* (2011) 243 CLR 506, [31] French CJ stated that when 'used in a statute, the term [public interest] derives its content from "the subject matter and the scope and purpose" of the enactment in which it appears'. Section 17(1) of the Act sets out the test, to be applied to determine whether disclosure of information would be contrary to the public interest. These factors are found in subsection 17(2) and Schedule 2 of the Act.

### **Schedule 2: Factors to be considered when deciding the public interest.**

While the majority of subject lines are to be released in full, the remaining subject lines have been assessed for factors favouring disclosure and nondisclosure, and therefore are required to be subject to the public interest test as set out in section 17 of the Act.

Taking into consideration the information contained in the documents found to be within the scope of your request, I have identified that the following public interest factors are relevant to determine if release of the information contained within these documents is within the 'public interest'.

#### ***Factors favouring disclosure (Section 2.1)***

- *Section 2.1(a)(i) - promote open discussion of public affairs and enhance the government's*

*accountability.*

- *Section 2.1(a)(ii) - contribute to positive and informed debate on important issues or matters of public interest.*

I consider that disclosing the contents of the information sought could contribute to open discussion and informed debate on the matters contained in the subject lines. I am satisfied there may be a public interest, however, I weigh these factors lightly as release of single subject lines alone may not reasonably contribute to informed debate.

I am satisfied that these factors favouring disclosure carry some weight. However, these factors are to be balanced against the factors favouring nondisclosure.

***Factors favouring nondisclosure (Section 2.2)***

- *Section 2.2(a)(ii) - prejudice the protection of an individual's right to privacy or any other right under the Human Rights Act 2004.*
- *Section 2.2(a)(iii) - prejudice security, law enforcement or public safety.*
- *Section 2.2(a)(xi) - prejudice trade secrets, business affairs or research of an agency or person.*
- *Section 2.2(a)(xvi) - prejudice a deliberative process of government.*

Where the names of members of the public appear in subject lines of ministerial briefs it is reasonable that this type of information is not released. I note that these brief titles are in reference to meetings between a Minister and non-ACT Government members of the public and the release of their names could or would reasonably be considered to prejudice their right to privacy under the *Human Rights Act 2004*. I note that these redactions are minor in nature.

A factor favouring nondisclosure under s 2.2(a)(iii) is that disclosure could reasonably be expected to prejudice security, law enforcement or public safety. The attached document contains information that I find may be prejudicial to the security of ACT Government employees if released. Therefore, I have given this factor moderate weight and decided not to release parts of the document where I find that there may be a risk to public safety, due to very specific information provided in that document.

I have also considered the impact of disclosing information which relates to business affairs. In the case of *Re Mangan and The Treasury* [2005] AATA 898 the term 'business affairs' was interpreted as meaning 'the totality of the money-making affairs of an organisation or undertaking as distinct from its private or internal affairs'. Schedule 2 section 2.2(a)(xi) allows for government information to be withheld from release if disclosure of the information could reasonably be expected to prejudice the trade secrets, business affairs or research of an agency or person. I have redacted the names of organisations to protect the affairs of organisations in this case.

Several subject lines refer to information that involves *competitive commercial activities of an agency*, therefore the factor for nondisclosure s 2.2 (a)(xiii) is relevant as it allows for government information to be withheld from release if disclosure of the information

could reasonably be expected to prejudice the trade secrets, business affairs or research of an agency or person.

There is one other factor that I viewed as relevant to the release of this information – that disclosure could prejudice a deliberative process of government.

According to the Ombudsman Guidelines *Considering the Public Interest* (2020) ‘a balance needs to be struck between ensuring that the government may function effectively and efficiently, and providing access to information to ensure increase public participation in, and scrutiny of, government activities’. This factor has been weighed moderately and applied sparingly where considerations are being deliberated and ongoing. I am satisfied that on balance, the information concerning prejudicing a deliberative process of government is considered not in the public interest and are exempt from disclosure.

Having applied the test outlined in section 17 of the Act and deciding that release of personal information contained in the document is not in the public interest to release, I have chosen to redact this specific information in accordance with section 50(2). Noting the pro-disclosure intent of the Act, I am satisfied that redacting only the information that I believe is not in the public interest to release will ensure that the intent of the Act is met and will provide you with access to the majority of the information held by CMTEDD within the scope of your request.

### Ombudsman Review

You have the right to seek Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is provided to you, or a longer period allowed by the Ombudsman.
