Ian Cox has requested a check from your area to a current draft Ministerial reply. The subject is a proposal to establish a light aircraft airfield at Williamsdale.

Ian had responded previously after seeking advice from Agency's including ACTPLA (Gerry Allens area). The proponent, Mr Christopher Price, was dissatisfied with Ian's response and in his reply to the CM made accusations of bias in ACTPLA's advice to CM's.

The draft reply is attached for your consideration. The passage re Mr Prices accusations is in blue on page 2.

Also attached are Ian's original letter, Mr Price response to that, and a subsequent detailed response to the points raised by Mr Price.

In short we checked with ACTPLA and other agencies with a knowledge of the landholders that could be affected by Mr Price's proposal and found no basis to support Mr Price's assertion of bias.

Hope it all makes sense.


