I refer to your request addressed to the Chief Minister and Treasury Directorate (CMTD) made under the *Freedom of Information Act 1989* (the Act). You are seeking access to the following documents relating to a **Special Shaped Balloon for the Centenary of Canberra**:

- Contracts, service agreements, and Deeds of Variation between the Australian Capital Territory and Global Ballooning P/L, relating to the commission and operation of [the Skywhale] including those omitted from publication on the Procurement website/confidential text; and
- Correspondence between CMTD and the Chief Minister's Office regarding the commission and operation of [Skywhale] from 1/1/12 to 16/5/13.

#### **Decision Maker**

I am authorised under section 22 of the Act to make decisions on access to documents and liability for charges.

On 19 June 2013, I released to you documents that fell under the second dot point of your request.

As indicated in my decision of 19 June 2013, and also in my letter to you of 4 June 2013, the documents that have been identified as relevant to your request under the first dot point contain information regarding the business and personal affairs of third parties. As such, under sections 27 and 27A of the Act, an opportunity was provided to third parties should they reasonably wish to contend that the documents should be treated as exempt under section 41 (personal privacy) or section 43 (business affairs) of the Act. I have considered third party submissions in making my decision to release or exempt the documents.

## Charges

I have decided, under section 29 of the Act, not to impose processing charges for this request.

#### **Identification of Documents**

Officers of CMTD have conducted thorough searches of paper and electronic files and email accounts. The documents that are relevant to your request are managed by the Culture and Communications Division.

#### **Decision on access**

I have decided to provide to you, in full, all documents within the scope of the request that fell under consultation with the only redaction being the removal of the personal details of the artist.

All relevant documents identified are listed on the attached schedule with a summary of my decision in relation to each. The information I have released to you is attached and outlined on the schedule.

## **Exemption claimed**

Documents affecting personal privacy

## Section 41 of the Act provides:

- (1) A document is an exempt document if its disclosure under this Act would involve the unreasonable disclosure of personal information about any person (including a deceased person).
- (2) Subject to subsection (3), subsection (1) does not apply to a request by a person for access to a document only because of the inclusion in the document of matter relating to that person.
- (3) Where-
  - (a) a request is made to an agency or Minister for access to a document of the agency, or an
    official document of the Minister, that contains information of a medical or psychiatric
    nature concerning the person making the request; and
  - (b) it appears to the principal officer of the agency, or to the Minister, as the case may be, that the disclosure of the information to that person might be prejudicial to the physical or mental health or wellbeing of that person;

the principal officer or Minister may direct that access to the document, so far as it contains that information, that would otherwise be given to that person is not to be given to that person but is to be given instead to a doctor to be nominated by that person.

# Your right of review

#### Internal Review

Under section 59 (1) of the Act, you may request a review of my decision. You have 28 days after receiving notice of my decision to ask for a review, or a further period as allowed by the Director-General.
