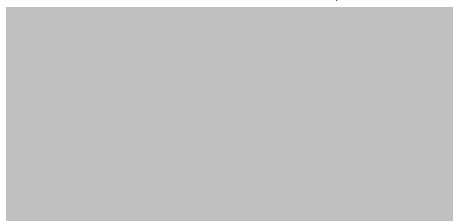

## **FREEDOM OF INFORMATION REQUEST – FURTHER RELEASE**

I refer to your application under section 14 of the ACT *Freedom of Information Act* 1989 (the Act), received by the Justice and Community Safety Directorate (the Directorate) on 9 February 2015 in which you sought access to the following:

*“All documents and any information held by the Directorate regarding contract 2014/1820-01... [including] ... correspondence regarding selection of the contractor, correspondence with the contractor and reports and accompanying information.”*

I am the officer authorised under section 22 of the Act to make a decision in relation to your request.

I note that I have previously provided you with a decision in relation to this request on 10 April 2015. In an email on 13 April 2015, you queried the non-release of three email attachments referred to in documents 13 and 14 (folios 101 and 112) of the documents provided to you. Two of the documents referred to were not released due to an oversight arising from the documents having been provided to the University of NSW (UNSW) electronically, and not being included on the paper files held by the Directorate. I have reviewed these documents and have decided that they can be fully released. The third document referred to is the document already released at folios 105 to 111.

Please find attached a schedule detailing the two additional documents being released. As these documents are in an Excel format which is more accessible electronically than in a printed format, I am attaching the documents electronically with this response.

As a result of identifying that, when processing your request, the Directorate overlooked some electronically supplied data, the Directorate is undertaking further inquiries to identify any other electronically supplied data that may have been supplied, to determine whether it is within the scope of your request.

You also asked if data requirements referred to within the documents released resulted in data being provided to UNSW and, if so, why it was not included with documents released in response to your request.

I can advise that some data was made available by providing UNSW with direct access to ACT Government data, from which the UNSW data expert extracted data required for the evaluation. No further ACT records falling within the scope of your request were generated as a result of, or in relation to, the extraction of this data.

As noted above, the Directorate is undertaking further inquiries to establish whether any other data was supplied electronically, which falls within the scope of your request. Advice on this will be provided to you by 28 April 2015.

In relation to the additional information being released today I have assessed the information under the ACT Government's Online Freedom of Information Publication Policy and have determined that the documents which will be fully released, including this decision letter, **will** be published online. You have the right to seek a review of this outcome under section 59 of the Act within 28 days from the date of this letter, or such other period as the Director-General permits. This right of review extends to a review of the adequacy of the search for documents undertaken by the Directorate. If you wish to seek a review you should write to:
