FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 3 January 2019, in which you sought access to information regarding parking infringement notices and revenue raised from Limburg Way, Greenway ACT.

Specifically, you are seeking: "details of how many parking infringement notices have been issued in 2018 between Limburg Way and Lake Tuggeranong. Adjacent 1 Limburg Way, Greenway."

You also requested "a copy of a document that details how much money has been raised by the ACT Government as a result of the infringement notices issued at this spot."

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance of section 40 of the Act, CMTEDD was required to provide a decision on your access application by 1 February 2019.

Decision on access

Searches were completed for relevant documents and 1 document was identified that falls within the scope of your request.

I note that you requested "a copy of a document that details how much money has been raised by the ACT Government as a result of the infringement notices issued at this spot" and the relevant business which was consulted for this request has confirmed that in 2018, a total of <u>48 parking infringement notices</u> were issued at that location, and <u>\$4374.00 was raised</u> from these infringement notices.

I have included as Attachment A to this decision a schedule outlining the relevant document. This provides a description of the document that falls within the scope of your request and the access decision for that document.

I have decided to grant full access to the relevant document. The document released to you is provided as Attachment B to this letter.

Charges

Pursuant to *Freedom of Information (Fees) Determination 2017 (No 2)* processing charges are not applicable for this request because the total number of pages to be released to you is below the charging threshold of 50 pages.
