### FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 27 March 2019.

Specifically, you are seeking: "All documents including correspondence, emails, briefings, inspection reports, legal advice, notes and minutes of meetings and discussions, records of telephone conversations and file notes relating to the Yarralumla Residents Association's letter to Mr Gordon Ramsay dated 29 July 2018 regarding the state of disrepair of the YMCA Community Hall located on the corner of Meuller St and Loftus St Yarralumla in and the failure to comply with the lease purpose clause which requires the building to be used for community/youth purposes."

### Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

## **Timeframes**

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 20 May 2019.

### Third party consultation

In determining this access request, I identified that some of the information may reasonably be expected to be of concern to a third party. In accordance with section 38 of the Act, I have undertaken third party consultation. The third party did not provide a response.

## Decision on access

Searches were completed for relevant documents and 55 documents were identified that fall within the scope of your request.

I have included as **Attachment A** to this decision the schedule of relevant documents. This provides a description of each document that falls within the scope of your request and the access decision for each of those documents.

I have decided to grant access in full to 51 documents relevant to your request. I have decided to grant partial access to 4 documents as I consider that they contain information which would, on balance, be contrary to the public interest to disclose under the test set out in section 17 of the Act.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as **Attachment B** to this letter.

In accordance with section 54(2) of the Act a statement of reasons outlining my decisions is below.

#### Statement of Reasons

In reaching my access decisions, I have taken the following into account:

- the Act:
- the content of the documents that fall within the scope of your request; and
- the Information Privacy Act 2014.

# **Exemption claimed**

My reasons for deciding not to grant access to components of these documents are as follows:

### **Public Interest**

The Act has a presumption in favour of disclosure. As a decision maker I am required to decide where, on balance, public interest lies. As part of this process I must consider factors favouring disclosure and factors favouring non-disclosure.

In *Hogan v Hinch* (2011) 243 CLR 506, [31] French CJ stated that when 'used in a statute, the term [public interest] derives its content from "the subject matter and the scope and purpose" of the enactment in which it appears'. Section 17(1) of the Act sets out the test, to be applied to determine whether disclosure of information would be contrary to the public interest. These factors are found in subsection 17(2) and Schedule 2 of the Act.

Taking into consideration the information contained in the documents found to be within the scope of your request, I have identified that the following public interest factors are relevant to determine if release of the information contained within these documents is within the 'public interest'.

# Factors favouring disclosure in the public interest:

- (a) disclosure of the information could reasonably be expected to do any of the following:
  - (ii) contribute to positive and informed debate on important issues or matters of public interest.

Having considered the factor identified as relevant in this matter, I consider that release of the information within the scope of the request may contribute to positive and informed debate on a matter of public interest and enhance the government's accountability. The documents identified contain information relating to the use and state of disrepair of a building in a busy area.

# Factors favouring nondisclosure in the public interest:

- (a) disclosure of the information could reasonably be expected to do any of the following:
  - (ii) prejudice the protection of an individual's right to privacy or any other right under the Human Rights Act 2004.

When considering the documents and factor in favour of non-disclosure, I have considered the personal information of staff members contained in the documents. I am satisfied that the names and contact information of ACT Government employees should be released as these individuals were acting in their official capacity and the personal information being released is done so in relation to these individuals exercising their delegations in a work related capacity. I do not consider the release of this information is unreasonable or could prejudice their right to privacy.

However, in considering the document and factor in favour of non-disclosure, I have considered the impact of releasing personal information contained in the document, being the name and contact information of an employee of the YMCA, and the harm it could have on the individual involved in the matters listed and I am satisfied that the release of this information is unreasonable and it would prejudice their right to privacy.

I am satisfied that the protection of an individual's right to privacy, especially in the course of dealing with a government agency, is a significant factor as the individual involved has provided their personal information as required and this, in my opinion, outweighs the benefit which may be derived from releasing the personal information of the individual involved. Individuals are entitled to expect that the personal information they have supplied as part of this process will be dealt with in a manner that protects their privacy. Considering the type of information to be withheld from release, I am satisfied that the factors in favour of release can still be met while protecting the personal information of the individual involved.

Having applied the test outlined in section 17 of the Act and deciding that release of personal information contained in the documents is not in the public interest to release, I have chosen to redact this specific information in accordance with section 50(2). Noting the pro-disclosure intent of the Act, I am satisfied that redacting only the information that I believe is not in the public interest to release will ensure that the intent of the Act is met and will provide you with access to the majority of the information held by CMTEDD within the scope of your request.

# Charges

Pursuant to *Freedom of Information (Fees) Determination 2017 (No 2)* processing charges are applicable for this request because the total number of pages to be released to you exceeds the charging threshold of 50 pages. However, the charges have been waived in this instance in accordance with section 107(2)(b) of the Act.

# Online publishing - Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents released to you

in response to your access application will be published in the CMTEDD disclosure log three days after the date of my decision. Your personal contact details will not be published.

Dear Minister

I am writing concerning the Community Hall located on the corner of Mueller St and Loftus St Yarralumla (Block 3 Section 53).

The building was originally established as a hall for the use of the Yarralumla community. It was subsequently leased to the Young Men's Christian Association of Canberra Inc and used by the YMCA Auxiliary for garage sales.

The last garage sale was held over five years ago in March 2013 and the building has not been used since for this or any other community/youth purpose. No maintenance has been undertaken and the building is now falling into a state of disrepair.

We understand that the concessional lease issued to the YMCA commencing on 20 May 2009 allows you to terminate the lease if the land is not used for a period of one year for the purpose for which the lease is granted.

Furthermore the lease requires the YMCA to maintain the building in a good state of repair.

Given the need for a community hall in Yarralumla the YRA considers that if the YMCA is not going to use the hall for community purposes or maintain it then they should be asked to surrender the lease or it should be resumed and the hall handed back to the community.

I would appreciate your view on what action the government is willing to take to return the hall to community use as originally intended.

I am writing concerning the Community Hall located on the corner of Mueller St and Loftus St Yarralumla (Block 3 Section 53).

The building was originally established as a hall for the use of the Yarralumla community. It was subsequently leased to the Young Men's Christian Association of Canberra Inc and used by the YMCA Auxiliary for garage sales.

The last garage sale was held over five years ago in March 2013 and the building has not been used since for this or any other community/youth purpose. No maintenance has been undertaken and the building is now falling into a state of disrepair.

We understand that the concessional lease issued to the YMCA commencing on 20 May 2009 allows you to terminate the lease if the land is not used for a period of one year for the purpose for which the lease is granted.

Furthermore the lease requires the YMCA to maintain the building in a good state of repair.

Given the need for a community hall in Yarralumla the YRA considers that if the YMCA is not going to use the hall for community purposes or maintain it then they should be asked to surrender the lease or it should be resumed and the hall handed back to the community.

I would appreciate your view on what action the government is willing to take to return the hall to community use as originally intended.







- The initial Crown lease over the site was granted under the Leases Act 1918 on 8 April 1969 for a term of 1 year commencing on 9 February 1961 (the date of the acceptance of the lease) and thereafter under continued occupancy. The lease was granted to the Young Men's Christian Association of Canberra Incorporated for the purpose of a Youth Centre.
- In 1987, the lessee applied for a longer term lease. On 8 September 1987, the lessee was offered a five year lease which was granted under the Leases Act 1918 for a term of 5 years commencing on 22 September 1987 for the purpose of a Community/Youth Centre.

The lease also included a 'Continued Occupancy' clause at Clause 6(f). The lease expired on 21 September 1992. Thereafter, the lessee occupied quarter to quarter.

• In 1993, the lessee applied for the grant of a further long term lease. However, as the lease had expired, they were advised to make application for a direct grant which was submitted in 1993.

The application did not progress. In 2005, the lessee's legal representative was advised that as the lease permitted continued occupancy, the lessee could apply for a further lease. An application for a further 99 year lease was submitted in 2008.

The application was approved and the new 99 year lease was granted Planning and Development Act 2007 on 20 May 2009. The lease commenced on the same date.

There are no complaints on the electronic files (Objective) for this property. There are no development applications on the electronic files. There are no electronic documents on the building file.

There is currently no evidence to suggest when the land was last used for its intended purpose. Communication via a telephone call to the lessee can verify this.


