First Action Plan 2019 - 2021

An ACT Government strategy to deliver equitable outcomes for Lesbian, Gay, Bisexual, Trans, Intersex & Queer (LGBTIQ+) people



This First Action Plan sits under the Capital of Equality Strategy and aims to make Canberra the most LGBTIQ+ welcoming and inclusive city in Australia.

Achieving this means that LGBTIQ+ people, their families and communities are: Visible, Valued and Respected.

## FIRST ACTION PLAN

This action plan explains the changes that the ACT Government wants to make by the end of 2021 to improve the lives of LGBTIQ+ Canberrans.

In addition to acting on immediate priorities, we are beginning work now that will be implemented in future action plans.

This action plan is not a comprehensive description of LGBTIQ+ issues in Canberra nor does it describe all services and activities that the government will continue to fund, such as essential services.

We will continue to engage with the community – reaching and raising the voices of the most marginalised members of LGBTIQ+ communities – to identify barriers to equality and develop solutions to overcome these barriers.

The success of this action plan will be measured as outlined in the Capital of Equality Strategy.



# REFORMS FOR AN INCLUSIVE CANBERRA



We will be making an inclusive Canberra by continuing reforms to have equal rights reflected in law, data and policies.

#### KEEPING PEOPLE Safe from Harm

- ★ Collaborate with intersex people, human rights organisations and healthcare professionals to form a plan on how prohibition of deferrable medical interventions on intersex people could operate in Canberra.
- ★ Ban sexuality and gender identity conversion practices.

#### **BIRTH CERTIFICATE REFORMS**

- ★ Amend the *Births Deaths and Marriage Registration*Act 1997 to improve processes for changing birth registration and birth certificates for trans and gender diverse people, particularly young people.
- ★ Create a single form for the purposes of seeking both a change in sex and change in name registration and review associated fees and waiver processes.

#### **ELIMINATING DISCRIMINATION**

★ Progress consultations on reforms to the Discrimination Act 1991, including reforming exceptions that have a discriminatory effect on the LGBTIQ+ community, drawing on recommendations of the Law Reform Advisory Council.



## UNDERSTANDING AND AWARENESS

We will be fostering understanding and awareness so that barriers to equality can be removed.

### SUPPORTING COMMUNITY & EMBRACING INTERSECTIONALITY

- ★ Support events that bring the LGBTIQ+ community together and highlight individual experiences.
- ★ Invest in initiatives for LGBTIQ+ people with disability, or who are Aboriginal and Torres Strait Islander, or from a culturally diverse or faith background through the second round of the Capital of Equality grants program.
- ★ Train ACT Government officers in LGBTIQ+ affirmative practices and develop specialist staff expertise in LGBTIQ+ matters.
- ★ Reflect LGBTIQ+ people in government advertisements and communications.
- ★ Reflect the voices of LGBTIQ+ populations in delivering the Welcoming Cities Standard for migrant and multicultural communities.







## **SERVICE IMPROVEMENTS**

We will be ensuring LGBTIQ+ people have equitable access to services and that they receive support that is both appropriate to their experience and responsive to their needs across all stages of life.



#### INCLUSION AND ACCESS FOR LGBTIQ+ PEOPLE, THEIR FAMILIES AND COMMUNITIES

- ★ Develop an LGBTIQ+ information hub
  to centralise information and discoverability
  of LGBTIQ+ affirmative services and supports
  in Canberra.
- ★ Prioritise doing business with organisations that provide inclusive and non-discriminatory services to the public.
- ★ Advertise vacancies on ACT Government boards and committees in a way that directly target LGBTIQ+ people and communities.
- ★ Invest in LGBTIQ+ support systems for Canberra's schools including the continuation of the Safe and Inclusive Schools initiative and making sure schools get good guidance about supporting students who are affirming their gender.
- ★ Develop gender affirming guidelines for psychologists and mental health professionals working with trans and gender diverse people.
- ★ Support initiatives that allow mainstream services to pledge that they are LGBTIQ+ inclusive.
- ★ Funding community-based organisations to deliver targeted, peer-led services for LGBTIQ+ people, their families and communities.
- ★ Reflect the voices of LGBTIQ+ people in the development of the Charter of Rights for Victims of Crime.

#### EVIDENCE GATHERING TO INFORM SERVICE IMPROVEMENTS

- ★ Analyse and identify barriers to LGBTIQ+ people accessing health services to inform improvements to health service delivery. This will include a focus on Aboriginal and Torres Strait Islander LGBTIQ+ people.
- ★ Assess the feasibility of establishing a community of practice of legal practitioners to support LGBTIQ+ people.
- ★ Analyse local data collected through the Writing Themselves In 4 study to inform future actions to support the health and wellbeing of Canberra's LGBTIQ+ young people.
