- The Strategic Closed Circuit Television (CCTV) Plan 2020-2022 (CCTV Plan) will:
  - Focus government effort and investment to continue to build the capability of the Public Safety CCTV Network to create safer public spaces, venues and events in the ACT and better support ACT Police to investigate crime and bring offenders to justice.
  - Support the activities of the government and ACT Policing to deliver safe and well managed public events.
  - Ensure strong governance around the use of the CCTV system by promoting the development of a new CCTV policy and reporting around the use of the Public Safety CCTV Network.
  - o Provide reassurance to the community of government effort to keep people safe whilst protecting their privacy and human rights.
  - Promote innovation in the use of CCTV to support other ACT Government business requirements.

Using the TRN network could allow for the installation of CCTV at locations that are outside of the fibred or mobile phone network in support of bushfire detection or rural crime investigations.
		18. Trailer Mounted CCTV Capability The government will investigate the feasibility, costs and benefits to establish CCTV capability that can be quickly deployed via trailer or vehicle. This capability would allow for a minimum delay in the easy and quick deployment of a CCTV capability to support short term events, incidents or crime hot spots.
