FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 6 August 2020, in which you sought access to 2009 Cabinet documents.

Authority

As an appointed Information Officer under section 18 of the Act, I am authorised to make a decision on access or amendment to government information in the possession or control of CMTEDD.

Timeframes

In accordance of section 40 of the Act, CMTEDD was required to provide a decision on your access application by 3 September 2020.

Decision on access

Your request cannot be processed as a Freedom of Information request as per section 13 (1) of the Act because the information requested is available to you under Part 3A of the *Territory Records Act 2002*.

As agreed between Cabinet Office and your office, the information you requested will be released to you by the Cabinet Office under the *Territory Records Act 2002* outside of the FOI Act.

Charges

Pursuant to *Freedom of Information (Fees) Determination 2017 (No 2)* processing charges are not applicable for this request because no documents are being released to you.
