Request under the Freedom of Information Act 1998

I refer to your request, dated 16 July 2012 where you sought access, under the *ACT Freedom of Information Act 1989* (FOI Act), to documents relating to:

"... documents pertaining to the successful tender for: 18251.110 (Master Key System ACT Health)".

I am the officer authorised under section 22 of the FOI Act to make a decision in relation to your request.

Decision

I have located the following relevant documents, folios 36 – 38, 48 – 49, 53 -54, 57, 59, 61, 63 – 66, 68a – 72, 74 – 75, 78 and 81 - 86 from file 2012/3958, folios 2 and 5-12 from file 2012/18205 and folios 1 - 2 of unfiled documents, which relate to ... documents pertaining to the successful tender for: 18251.110 (Master Key System ACT Health) , which you refer to in your request:

- from file 2012/3958 folios 36 – 38, 65 – 66, 68a -72, 74, 78, 81 - 83 and 86 are fully released;
- from file 2012/18205 folios 5, and 7-12 are fully released;
- from file 2012/3958 folios 53 – 54, 59 and 64 are partially redacted;
- from file 2012/3958 folios 48 – 49, 57, 61, 63, 75 and 84 - 85 are exempted;
- from file 2012/18205 folios 2 and 6 are exempted;
- from unfiled documents folios 1-2 are exempted.

The partially redacted or exempt documents are not release in accordance with following sections of the FOI Act:

- section 43 – 'documents relating to business affairs';
- section 45 – 'documents containing material obtained in confidence'.

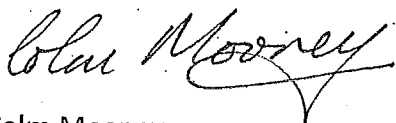
