FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 31 January 2018, in which you sought access to documents relating to your infringement notice.

Specifically, you are seeking:

- Information relating to vehicle infringement notices with offence description 'Code 301 Disobey no stopping sign', issued to vehicles parked at the approximate location of 42 Mort Street Braddon since 01 July 2017 until the present time. The information should include the following: date, time of infringement, confirmation of the infringement amount, whether or not the infringement was challenged by the vehicle driver, and whether or not the person challenging the infringement was successful; and
- any documents in regards to agreements between the ACT Government entity responsible for parking enforcement and any sub-contractor acting as 'authorized person'; and
- documents in relation to the sub-contractor's responsibility to issue the Parking Infringement Notice 

On 19 February 2018 you requested that the date range be pushed back 12 months to cover 1 July 2016 to 30 June 2017. This extra data has been incorporated into the applicant binder for you.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5.

Timeframes

CMTEDD was required to provide a decision on your access application by 28 February 2018.

Decision on access

Searches were completed for relevant documents and 2 documents were identified that falls within the scope of point 1 of your request.

No documents were found in relation to point 2 of your request as the ACT Government does not outsource or sub-contract these positions. Point 3 of your request was dependent on finding documents relating to point 2 and so is not applicable.

I have included as Attachment A to this decision the schedule of relevant documents. This provides a description of each document that falls within the scope of your request and the access decision for each of those documents.

Having considered the requirements of the Act, I have decided to grant full access to all documents. The documents released to you are provided as Attachment B to this letter.

Charges

Pursuant to *Freedom of Information (Fees) Determination 2017 (No 2)* processing charges are not applicable for this request as the total number of pages to be released to you is below the charging threshold of 50 pages.

Online publishing – Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents released to you in response to your access application will be published in the CMTEDD disclosure log after 2 March 2018.
