Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 3 February 2020.

Decision on access

Searches were completed for relevant documents and nine documents have been identified that fall within the scope of your request.

I have included as **Attachment A** to this decision a schedule which outlines the relevant documents. This provides a description of the documents that fall within the scope of your request and the access decision for each document. I note that Ultimate Tunes and Services in no longer an Approved Inspection Station therefore no documents were found.

I have decided to grant full access to all documents. A copy of the documents is provided as **Attachment B** to this letter.

Charges

Processing charges are not applicable for this request because the number of pages to be released to you is below the charging threshold of 50 pages.
