Summary of impacts:

- The submission highlights the benefits of the SPIRE project's location, including that the project can be delivered with minimal impact on existing campus operations, including access to these services by the public.
- The submission acknowledges that safe traffic flow, traffic and parking within the Canberra Hospital campus; and the management of impacts on local community and school, and on the safety of the community; emergency vehicle and helicopter access and the impact of helicopter noise on surrounding residences and school will be considered in the development of the Master Plan.
- The submission highlights how the ACT Government is supporting significant expansion and investment in health care services to respond to the community's needs.
