FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 8 October 2021.

Specifically, you sought: "Any document/information/record: - Provided to energy providers related to and defines what is an emergency repairs during COVID and the latest lockdown. - Why this is considered a safety concern and the decision to put this process of emergency repairs in place. Such as the cold in Canberra in winter and the risk to the public. - If available specifically relating to emergency heating repairs conducted by providers such as ActewAGL energy shop. ActewAGL have advised that they were provided with quidelines".

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application by 5 November 2021.

Decision on access

A search of CMTEDD records has failed to identify any documentation in relation to your request. The search was conducted using the information you provided.

I am satisfied that appropriate searches were completed and that no documents relevant to your request are held by CMTEDD.

Additional Information

I believe the information requested refers to the Public Health Direction that allows for urgent repair or maintenance to be undertaken without requiring an exemption, which would be the COVID task force. The COVID task force falls within the ACT Health Directorate.

Noting this, your application was transferred to ACT Health on 21 October 2021. In accordance with section 57(3) of the Act, this date is now taken to be the date the request was received.
