## **FREEDOM OF INFORMATION REQUEST**

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 21 October 2024. Specifically, you are seeking:

*“Correspondence between ACT Government and Gungahlin United regarding money owed and agreed repayment plan for the debt. Also correspondence between ACT Government and Capital Football and clubs regarding money owed. Search for 2023.”*

### **Authority**

I am an Information Officer appointed by the CMTEDD Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

### **Timeframes**

In accordance with section 40 of the Act, CMTEDD is required to provide a decision on your access application within 30 days.

Therefore, a decision is due by **02 December 2024**.

### **Decision on access**

Thorough searches of CMTEDD records have failed to identify any documentation in relation to your request. The searches were conducted using the information you provided.

I am satisfied that appropriate searches were completed and that no documents relevant to your request are held by CMTEDD.

### **Charges**

Pursuant to *Freedom of Information (Fees) Determination 2017 (No 2)* processing charges are not applicable for this request as no documents are being released to you.
