I refer to your application under section 14 of the *Freedom of Information Act 1989* (FOI Act), received by the Economic Development Directorate (EDD) on 27 August 2012.

You sought access under the Act to the following documents:

- *"All submissions, comments, responses or other feedback from or otherwise, to the Hawker Group Centre Draft Master Plan released for public comment during December 2011.*
- *The Friends of Hawker Village will not object to the release to it of copies of documents from which the name, address, email address or any other words that identify any person of organisation that provided comment, feedback etc has been removed".*

I am an officer authorised to make a decision in respect of a request for information, under section 22 of the FOI Act.

Decision

The Directorate has identified a number of documents in its possession that meet the scope of your request, as identified in the schedule attached to this letter. I am releasing all of the relevant documents held by the directorate to you, although I have decided to exempt some material from release, in accordance with the below mentioned exemption provisions.

41 Documents affecting personal privacy

(1) A document is an exempt document if its disclosure under this Act would involve the unreasonable disclosure of information relating to the personal affairs of any person (including a deceased person).

The exempt material contains information relating to the personal affairs of a third party.

43 Documents relating to business affairs

(1) (c) (ii) A document is an exempt document if its disclosure under this act would disclose – information (other than trade secrets or information to which paragraph (b) applies) concerning a person in respect of his or her business or professional affairs or concerning

the business, commercial or financial affairs of an organisation or undertaking, being information – (ii) the disclosure of which under this Act could reasonably be expected to prejudice the future supply of information to the Territory or an agency for the purpose of the administration of a law or the administration of matters administered by an agency.

(1) (b) A document is an exempt document if its disclosure under this act would disclose – any other information having a commercial value that would be, or could reasonably be expected to be, destroyed or diminished if the information were disclosed;

The exempt material contains information relating to the personal affairs of a third party.

Please note that some information has been exempt because it was out of the scope of the request (OOS.)

Review rights

My decision is appealable under the Act. This means that if you are dissatisfied with this outcome you have a right to seek a review under section 59 of the Act. This right of review extends to a review of the adequacy of the search for documents undertaken by the Directorate. If you wish to seek a review you should write to:

You have 28 days from the date of this letter to seek a review of the outcome or such other period as the Director-General permits.
