Decision on your Freedom of Information Request - Rage Cage Sports Court

I refer to your request, made under the *ACT Freedom of Information Act 1989* (the Act), for access to documents relating to the Rage Cage sports court at the Franklin Community Recreation Irrigated Park (CRIP) site, received by the Land Development Agency (LDA) on 8 June 2016.

With consideration to the additional information provided in your request, you are seeking: *"... the certification engineering documents in full and without bias or omissions which were supposed to be signed off for the concrete slab for the Rage Cage sports court at the Franklin CRIP site on approximately 14/1/15 or near after."*

Decision Maker

As previously advised, I am authorised under section 22 of the Act to make decisions on access to documents and liability for charges.

Charges

I have decided, under section 29 of the Act, not to impose processing charges for this request.

Identification of Documents

CMTEDD officers have conducted thorough searches of paper and electronic records for documents that may relate to your request. One relevant document – a Site Visit Record dated 22 January 2015 – was located and is attached with this letter.

Decision on Access

As previously advised, I consulted with a third party, under section 27 of the Act, prior to making my decision on release of the document. The third party's period for seeking a review of my release decision has expired, and I am now able to release the relevant components of the identified document to you.

The redacted components of the document concern aspects of the Franklin CRIP unrelated to your specific request; for that reason I have not released this information.

Your Right of Review

Internal Review

Under section 59 (1) of the Act, you may request a review of my decision. You have 28 days after receiving notice of my decision to ask for a review, or a further period as allowed by the Director-General.
