

FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 8 November 2018, in which you sought access to all transfers and copies of sales contracts for the following transactions:



Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance of section 40 of the Act, CMTEDD is required to provide a decision on your access application by 6 December 2018.

Decision on access

A search of documents was conducted and the relevant business area has confirmed that the information you have requested is available for a legislated fee from the ACT Land Information System at https://actlis.act.gov.au/.

Noting that the information requested is available for purchase, I have decided to refuse to deal with your access application in accordance with section 43(1)(d) of the Act. In making this decision I note the operation of section 45 of the Act, which prescribes the circumstances which government information is already considered available. In this instance, I note that information is considered to be available if the information is 'usually available for purchase' — see section 45(f).

Charges

Processing charges are not applicable for this request because no documents are to be released.

Online publishing - Disclosure Log

Under section 28 of the Act, CMTEDD maintains an online record of access applications called a disclosure log. A description of the access application and my decision will be published in the CMTEDD disclosure log after 20 November 2018. Your personal contact details will not be published.

Ombudsman Review
