

FREEDOM OF INFORMATION REQUEST

I refer to your application under section 30 of the Freedom of Information Act 2016 (the Act), received by the Chief Minister, Treasury and Economic Development Directorate (CMTEDD) on 14 January 2019, in which you sought access to information regarding the taxi fare review and taxi and ride share services in the ACT.

Specifically, you are seeking: "Taxi Fare Review undertaken by PSI Asia Pacific; - Data transmitted to the Centre for International Economics analysis by the ACT Government in order to undertake the consulting work performed as reflected in their 2 consulting reports in 2017. – List of current authorised Taxi Base Service's in the ACT. - List of current ride-share authorised booking services in the ACT."

On 21 January 2019 part of your request was transferred to Justice and Community Services Directorate (JACS) as the responsible agency for the *Taxi Fare Review undertaken by PSI Asia Pacific*.

Authority

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

Timeframes

In accordance of section 40 of the Act, CMTEDD was required to provide a decision on your access application by 12 February 2019.

Decision on access

Searches were completed for relevant documents and 1 document was identified that falls within the scope of your request.

I note that you requested a "List of current authorised Taxi Base Service's in the ACT and a list of current ride-share authorised booking services in the ACT" the relevant business area was consulted and have provided a list, however they have advised that Access Canberra do not authorise taxi base services in the ACT. Access Canberra accredits transport booking services of which some may provide taxi booking services. The same applies to the rideshare booking services, which are not authorised but accredited.

I have included as **Attachment A** to this decision a schedule outlining the relevant document. This provides a description of the document that falls within the scope of your request and the access decision for that document.

I have decided to grant full access to the relevant document. The document released to you is provided as **Attachment B** to this letter.

Charges

Pursuant to Freedom of Information (Fees) Determination 2017 (No 2) processing charges are not applicable for this request because the total number of pages to be released to you is below the charging threshold of 50 pages.

Online publishing - Disclosure Log
